Mr. and Mrs. Wood have volunteered to lock the bathrooms each night and Public Works will open them in the morning. Commissioner Gibson mentioned the gate is not working properly. Commissioner Bittle stated she would like to have the gate fixed and the back of the park fenced in the New Year.

Commissioner Bittle congratulated the Commissioners on working together and making decisions that have benefitted the City.

Commissioner Gibson stated the results were back from the Evidence locker audit and everything was found in compliance.

Vice Mayor Hyatt congratulated Commissioner Bittle and her husband on the success of the City parade and wished everyone a Merry Christmas.

Mayor Mary Lee Cook stated this year's parade seems to have been the best so far. She also congratulated the Commission on their hard work in the past year and is looking forward to accomplishing more this coming year.
