### A. OPENING

- C. CITY ADMINISTRATION REPORTS
  - 1. Proposed Millage Rate and Budget Hearings

Vice Mayor Hyatt made a motion, seconded by Commissioner Gibson, that the proposed miliage rate would be 6.3375, the same as the roll-back rate. Roll Call Vote: Mayor Cook, Yes; Vice Mayor Hyatt, Yes; Commissioner Engele, Yes; Commissioner Gibson, Yes. The motion carried, 4-0.

By consensus, the Commission scheduled Budget Hearings on: 5:30 PM on Monday, September 10 and 5:30 PM on Monday, September 24.

The Commissioners also scheduled Budget Workshops on: 5:00 PM on Monday, August 13 and 5:00 PM on Monday, August 27.

# 2. CDBG Mandatory Pre-Bid Conference

The contractors that qualified for construction work on the City's CDBG Housing Rehabilitation Program must attend a Pre-Bid Conference on July 24 and 25 in preparation for offering their sealed bids. The Commission would like for a representative of the City to attend if possible, and to provide a report to the Commission.

# D. CITIZEN PARTICIPATION (Non-agenda – 15 Minutes)

Vicki Morgan, 263 Randle, as treasurer of the Garden Club, reported that the Garden Club contributed \$200 toward the Oak Hill Community Trust's purchase of new blinds for the

VIA Hall. Jeany Gonzalez, City Hall Administrative Assistant, added that the City also contributed toward this purchase.

Richard Taylor, 210 Randle, concerned about tax bill differences among Indian Harbor Estates residents, asked the City to proceed with forced annexation of all remaining parcels in that area. There was discussion about the Inter-local Agreement signed in 2011 with the County, and why the remaining properties do not qualify for another Inter-local Agreement. The City Attorney explained the only other involuntary annexation possible would be by majority vote at the polls. The Commission will re-address the issue at the next meeting.

Mr. Simpson stated that the Waverly Group's request to discuss advertisement sign would be referred to Commissioner Engele, who would contact DOT. The Commission would like to research the Direct-A-Way signs agreement.
