# **RESOLUTION #2012-10**

A RESOLUTION OF THE CITY OF OAK HILL, VOLUSIA COUNTY, FLORIDA, ADOPTED PURSUANT TO SECTION 2-325 OF THE OAK HILL CODE OF ORDINANCES AUTHORIZING THE NEGOTIATION OF A CONTRACT WITHOUT REGARD TO PURCHASE PRICE; APPROVING A CONTRACT WITH JULIE L. WOODS FOR CONSULTING; PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE.

Commissioner Gibson made a motion, seconded by Commissioner Engele, to approve Resolution 2012-10 as read. Roll Call Vote: Mayor Cook, Yes; Vice Mayor Hyatt, Yes; Commissioner Engele, Yes; Commissioner Gibson, Yes. The motion carried, 4-0.

# I. OLD BUSINESS

1. Public Works Building

Commissioner Engele state he was getting the bid information together for the Public Works Building and he asked the Commission if he could move forward and place an ad in the Newspaper. Vice Mayor Hyatt stated that the survey should be cleared before the City asks for bids. The City Planner also stated Commissioner Engele should confer with the Building Official in regards to requirements of the Fire Marshall and how close the building can be to City Hall.

Lyn Seaward, Ezra Rd, asked about water and septic for the building.

After some discussion the Commission agreed to go ahead with the ad requesting bids when Commissioner Engele has the bid papers completed.

# J. NEW BUSINESS

1. City Attorney Contract (Gibson)

Commissioner Gibson stated that after some research he had found the City Attorney does not have a contract with the City and he suggested the Commission look at getting one.

The City Attorney stated he had sent a draft of the contract to the Commissioners for their input. The Attorney stated that this contract allows Commissioners to individually request the Attorney's time up to four hours; he recommends this provision be removed and have all correspondence go through the City Clerk. After some discussion the Commission agreed to remove that provision and put the contract on the next agenda. The City Attorney stated he will send the revised contract to the Commission before the next meeting.

# 2. Synthetic Drug Resolution (Hyatt)

Vice Mayor Hyatt expressed concern of Synthetic Drugs being sold in Oak Hill. The City Attorney stated some cities in Volusia have already adopted Resolutions in regards to this case and he inquired if the Captain would like to speak on the subject.

Captain Summers recommended the ordinance that Palm Coast adopted and he will send a copy to the City Clerk.
