The City Clerk welcomed the new Commission and stated there are Florida Sunshine and Newly Elected Official courses available and that information will be forwarded to them.

The City Clerk informed the Commission every year the City gives \$1000 to the Oak Hill parade and it is time to do that again.

Vice Mayor Bracy made a motion, seconded by Commissioner Livingston, to approve issuing a check for \$1000 to the Oak Hill Community Trust for the annual Christmas Parade. I. OLD BUSINESS

1. Master Plan (Zahn Engineering)

The City Clerk informed the Commission she had spoken with Pete Zahn and he would adjust the original Master Plan for water to show US 1 as Phase 1 for \$1375. No action was taken at this time.

2. Tri-Party Agreement Meeting (Gibson)

The Mayor stated he had met with Tracy Barlow the City Manager for Edgewater and he stated that Edgewater is ready to assist Oak Hill in any way it can. The Commission agreed to have a Workshop after the Mayor and the City Planner meet with the County.

3. Personnel Manual (Gibson)

The Mayor asked where the Personnel manual in being reviewed. The City attorney stated that even though the HR specialist was unable to review the manual at this time she suggested to the City to compare the City's Personnel Manual Draft with the Brevard County Personnel Manual, which is the model she uses.

The Commission directed the City Clerk to obtain a copy of the Brevard manual and compare it to the City's Personnel Manual Draft.
