C. ORDINANCE #2014-07

AN ORDINANCE OF THE CITY OF OAK HILL, VOLUSIA COUNTY, FLORIDA ADOPTED PURSUANT TO FLORIDA STATUTE SECTIONS 101.161 AND 166.031 SETTING FORTH A NEW CITY CHARTER TO BE SUBMITTED TO THE VOTERS OF THE CITY AT THE NEXT REGULARLY SCHEDULED ELECTION; PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE.

The City Clerk read Ordinance 2014-07 into record by heading only.

After discussion the commission agreed to amend Section 4.07 Filling of vacancies; to state the "If the commission cannot agree on a nomination within 60 days the Mayor may appoint one of the qualified nominated individuals to the vacant seat."

Commissioner Engele made a motion to approve Ordinance 2014-07 as read including the amendment of Section 4.07, seconded by Commissioner Bittle. 


