The City Administrator read the ordinance into record by heading only.

1. ORDINANCE NO. 2015-12

AN ORDINANCE OF THE CITY OF OAK HILL, VOLUSIA COUNTY, FLORIDA AMENDING CHAPTER 24 (LAND DEVELOPMENT REGULATIONS) ARTICLE V. (ZONING: USE, DENSITY AND INTENSITY) SECTIONS 24-453(MH-1 MOBILE HOME SUBDIVISION CLASSIFICATION) AND 24-493 (EXCEPTIONS TO MINIMUM YARD OR LOT COVERAGE REQUIREMENTS) OF THE CITY OF OAK HILL CODE OF ORDINANCES; PROVIDING FOR CONFLICTING PROVISIONS, SEVERABILITY AND APPLICABILITY; PROVIDING FOR CODIFICATION AND AN EFFECTIVE DATE.

Montye Beamer stated this Ordinance includes the changes suggested by the Commission.

The Mayor stated Ms. Beamer had sent an email on March the 26th that stated the only changes made to the MH-1 classification were the following: adding the word Urban to differentiate this classification from the City's MH-4 classification, including single family and manufactured modular as a permitted use, deleted the depth and minimum project size requirement to allow for subdivision.

Douglas Kennedy, Gary Avenue, spoke of the annexations and zoning map; and he identified missing properties that were not included and therefore stated this ordinance is in violation of Florida Statutes.

Vice Mayor stated he thinks the 1999-06 Ordinance which was adopted should be kept as is.

Commissioner Hyatt stated she agrees with the City Attorney in regards to this ordinance, as gives the property owners more options and takes nothing away.

ORDINANCE NO. 2015-02

AN ORDINANCE OF THE CITY OF OAK HILL, VOLUSIA COUNTY, FLORIDA, AMENDING THE LAND DEVELOPMENT REGULATIONS BY ADOPTING A NEW OFFICIAL ZONING MAP TO DESIGNATE THE ZONING DISTRICTS FOR PROPERTIES REZONED SINCE NOVEMBER, 1992, TO ADD CITY ZONING DISTRICTS CONSISTENT WITH COUNTY CLASSIFICATIONS FOR PROPERTIES ANNEXED SINCE NOVEMBER, 1992, AND TO RESTATE THE ZONING DISTRICTS FOR THOSE PROPERTIES LOCATED IN THE CITY WHERE NO OFFICIAL ACTION OCCURRED SINCE NOVEMBER, 1992; PROVIDING FOR THE REPEAL OF THE EXISTING OFFICIAL ZONING MAP FOR THE CITY OF OAK HILL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS AND PROVIDING FOR AN EFFECTIVE DATE.

Montye stated Ordinance 2015-12 may need a super majority vote and since the Commission does not have one she recommends the Commission continue the Public hearing for Ordinance 2015-02 until the City Attorney is contacted.

Darrin Elkin, legal representation for a property owner on River Road asked if the Ordinance will be re noticed and if he could set up a meeting with staff.

Morehead, Scottsmoor, stated he feels his property should be commercial and presented a letter for the record.
