Mr. Rebman stated he is a teacher and to help his students learn more about homelessness he lived as a homeless person for a few months. He explained the reason why he is speaking in front of the Commission is to urge them to demand Volusia County become the leader of the Cities to find a viable plan to alleviate the homeless population. He stated the County's plan of building a shelter in Daytona Beach and then turning over the maintenance to the cities.

In closing he urged the City to demand the County start looking at a viable plan to alleviate the homelessness in the City of Oak Hill and the rest of the county.

1. Highlander RV Park Special Exception

The City Planner stated this is a request for a permitted Special Exception for a R.V Park in a Agricultural zoning District; this item was tabled to allow for the applicant to meet with staff and provide further information. Staff did meet with the applicant and the additional information was received. Staff recommends approval with the following conditions:

- 1. The applicant shall submit a site plan complying with all applicable Land Development Code regulations and requirements. This site plan shall be submitted prior to Site Plan Review.
- 2. Prior to any road improvements, the applicant shall submit documentation to the City from each affected easement holders indicating agreement to the improvements.
- 3. The RV lots/spaces and proposed structures/buildings shall maintain a minimum 100 foot setback from the edge of the existing airstrip.
- 4. The applicant shall comply with all rules applicable to mobile recreational vehicles as specified by the Department of Health and Rehabilitative Service or provide documentation from said agency it is not required.

AN ORDINANCE OF THE CITY OF OAK HILL, VOLUSIA COUNTY, FLORIDA, AMENDING THE LAND DEVELOPMENT REGULATIONS BY ADOPTING A NEW OFFICIAL ZONING MAP TO DESIGNATE THE ZONING DISTRICTS FOR PROPERTIES REZONED SINCE NOVEMBER, 1992, TO ADD CITY ZONING DISTRICTS CONSISTENT WITH COUNTY CLASSIFICATIONS FOR PROPERTIES ANNEXED SINCE NOVEMBER, 1992, AND TO RESTATE THE ZONING DISTRICTS FOR THOSE PROPERTIES LOCATED IN THE CITY WHERE NO OFFICIAL ACTION OCCURRED SINCE NOVEMBER, 1992; PROVIDING FOR THE REPEAL OF THE EXISTING OFFICIAL ZONING MAP FOR THE CITY OF OAK HILL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS AND PROVIDING FOR AN EFFECTIVE DATE.
