**ORDINANCE #2015-22** 

Attorney read heading into record.

AN ORDINANCE OF THE CITY OF OAK HILL, FLORIDA, AMENDING ITS LAND DEVELOPMENT REGULATIONS, BY ADDING SECTION 24-464 (ACPD – ACTIVITY CENTER PLANNED DEVELOPMENT ZONING CLASSIFICATION); PROVIDING FOR CODIFICATION; PROVIDING FOR PUBLIC HEARINGS; PROVIDING FOR SEVERABILITY; REPEALING ALL LAWS OR PARTS OF LAWS IN CONFLICT HEREWITH; AND PROVIDING WHEN THIS ORDINANCE SHALL TAKE EFFECT.

Beth Lemke stated this Ordinance is creating the zoning classification consistent with the Comprehensive Plan. Vice Mayor Bracy stated he was concerned with a boat building factory being allowed. He also stated there may be an issue with an easement on the property in question and suggested the applicant contact the affected property owners.

Clay Erving, whom is representing the property owner, stated there is no issue with removing the boat building use from the agreement. Motion: Approval striking Boat building, Action: Approve, Moved by Commissioner Bittle, Seconded by Mayor Gibson after passing the gavel to Vice Mayor Bracy.
