

**I. NEW BUSINESS**

1. Reasonable Assurance Plan for the Mosquito Lagoon

**The City Administrator stated this plan is part of the Volusia County Water Quality Plan as a step to begin to improve the water quality of Mosquito Lagoon and other bodies of water in Volusia County. Another benefit of creating the Reasonable Assurance Plan (RAP) is to work along with the Department of Environmental (DEP) services to implicate steps to help Mosquito Lagoon recover from past pollutants and algae blooms. The City Administrator stated, working with DEP now before the Lagoon is deemed impaired, will show that the Cities and County are committed to improving water quality and have already taken steps to protect the waters, therefore avoiding possible fines and stricter regulations. This plan will cost a total of \$378,000 with the City of Oak Hill's portion being \$25,000 that can be made in three payments.**

**The Vice Mayor questioned what the shellfish harvesters and fishermen think of this plan.**

**The Mayor questioned the section on funding that the City Attorney pointed out in regards to the subject of change orders and requested the City Administrator to clarify that portion with the County.**

**The commission agreed to table this item until the first meeting in January.**

**RESOLUTION 2015-14**

**A RESOLUTION OF THE CITY OF OAK HILL, VOLUSIA COUNTY, FLORIDA, REQUESTING THE VOLUSIA CHARTER REVIEW COMMISSION TO RECOMMEND AN AMENDMENT TO THE VOLUSIA COUNTY CHARTER EITHER ELIMINATING THE VOLUSIA GROWTH MANAGEMENT COMMISSION OR ALTERNATIVELY LIMITING THE JURISDICTION OF THE VOLUSIA GROWTH MANAGEMENT COMMISSION TO ONLY CONDUCT REVIEWS AND HEARINGS OF PROPOSED COMPREHENSIVE PLAN AMENDMENTS OF LOCAL GOVERNMENTAL ENTITIES**

**WHEN AN OBJECTION TO A PROPOSED COMPREHENSIVE PLAN AMENDMENT IS FILED BY ANOTHER LOCAL GOVERNMENTAL ENTITY; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTING RESOLUTIONS; AND PROVIDING AN EFFECTIVE DATE.**


**M. COMMENTS AND CONCERNS FROM THE COMMISSIONERS**

**The Mayor stated he attended the Volusia County Council meeting in regards to the ban of seine nets and the council declined to move forward with removal of the ban.**


