
**L. CITIZEN PARTICIPATION (NON AGENDA ITEMS)**

**M. COMMENTS AND CONCERNS FROM THE COMMISSIONERS**


The Mayor stated that his opponent has withdrawn from the election and therefore he will be the Mayor of Oka Hill for another 4 years.
