1. ORDINANCE NO. 2017-09

AN ORDINANCE OF THE CITY OF OAK HILL, VOLUSIA COUNTY, FLORIDA AMENDING CHAPTER 24 ARTICLE II. (RULES OF INTERPRETATION AND DEFINITIONS): SECTION 24-40 (DEFINITIONS); ARTICLE V. (ZONING) ZONING CLASSIFICATIONS; ARTICLE V. SECTION 24-501 (SPECIAL EXCEPTIONS), OF THE CITY OF OAK HILL CODE OF ORDINANCES; PROVIDING FOR CONFLICTING PROVISIONS, SEVERABILITY AND APPLICABILITY; PROVIDING FOR CODIFICATION AND AN EFFECTIVE DATE.

Commissioner Lindau stated he is concerned that a drive thru is omitted.

Motion: To Approve Ordinance 2017-09 with the addition of allowing drive thru, Action: Approve, Moved by Commission Bracy, Seconded by Commissioner Bittle. Commissioner Bittle voted no.

Commissioner Bracy asked the City Planner the reason the property located on US Hwy 1 owned by Blake Lee is required to become commercial and not Agricultural. He went on to explain that Volusia County has 4 Agricultural zonings and he believes the City should have the same type of options. He also stated the City should move forward with the Comprehensive Plan change for Agriculture requiring 5 acres to only requiring 2.5 acres.

The City Planner stated she had concerns in the level of service the City can provide, she explained she makes her recommendations by what the City has adopted in their comprehensive Plan and other codes. She went on to state that the Future Land use is what is hindering that property in becoming agriculture. The City will need to justify the additional services.

The Commission discussed different options and scenarios for the property.

David Lee stated that the kids of Oak Hill are leaving, and the City needs to make changes to keep them here.

Blake Lee voiced his concern that he cannot use his property as he wishes, and he feels the City should make changes.

The City Administrator voiced her concern that the Commission needs to give her direction to make the changes to the Comprehensive plan.

The City Planner stated that the Commission can decide to go against the planner recommendation and give Mr. Lee the Agricultural zoning he is requesting.

The Commission agreed that is the direction they would like to be brought to them.
