B. PRESENTATIONS - Ben Johnson, former Volusia County Sheriff, stated he will be running for County Council (at large seat) this year and he looks forward to being able to work with Oak Hill again.

Mayor Gibson recognized Jim Cameron and thanked him and the Daytona Chamber of Commerce for all their efforts at the Legislation this year, even though the City's request was not accepted.

Jim Cameron stated he enjoyed working with Oak Hill and they have already begun plans for next year.

C. CITY ADMINISTRATION REPORTS

1. Review of the Bills and Paid Interim Bills for March 7, 2018

The Mayor asked about the Dex Imaging bill and the Administrator stated that was to get out of the City's contract and the City was reimbursed by the new leasing company.

The City Administrator stated she would be out of town from March 22, 2018 thru March 27, 2018.

3. Food Give Away -

The City Administrator stated there were quite a bit of complaints from citizens in regard to the food give away at the Upper Room Chapel, apparently roads and driveways were being blocked.

1. **RESOLUTION NO. 2018-03**

A RESOLUTION OF THE CITY OF OAK HILL, FLORIDA REQUESTING AND SUPPORTING THE COUNTY COUNCIL OF VOLUSIA COUNTY PLACING A BALLOT QUESTION ON THE 2018 ELECTION BALLOT FOR A ONE-HALF CENT INFRASTRUCTURE SALES TAX TO BE LEVIED FOR TWENTY YEARS; PROVIDING FOR SEVERABILITY, PROVIDING FOR CONFLICTING RESOLUTIONS AND PROVIDING AN EFFECTIVE DATE.

The Mayor stated that even though the commission is not in agreeance with the distribution he does believe this should be put in front of the voters to decide.

Motion passed unanimously.

2. RESOLUTION NO. 2018-04

A RESOLUTION AUTHORIZING THE CITY COMMISSION OF THE CITY OF OAK HILL, FLORIDA, AUTHORIZING THE CHIEF ELECTED OFFICIAL TO MAKE APPLICATION TO THE, FLORIDA INLAND NAVIGATION DISTRICT WATERWAYS, ASSISTANCE PROGRAM, FY 2018; PROVIDING AN EFFECTIVE DATE.

The City Administrator stated if the City is not able to obtain the matching funds through other grants, the City will not be able to provide the funds.

Beth Lemke stated her firm is pursuing other grant options and she feels confident the City will succeed.

AN ORDINANCE OF THE CITY OF OAK HILL, VOLUSIA COUNTY, FLORIDA ANNEXING BY VOLUNTARY PETITION PROPERTY LOCATED AT 745 SOUTH US HIGHWAY 1; REDEFINING BOUNDARIES OF THE CITY OF OAK HILL TO INCLUDE SAID PROPERTY; DIRECTING THE CITY CLERK TO FILE THE ORDINANCE WITH THE CLERK OF THE CIRCUIT COURT, WITH THE CHIEF ADMINISTRATIVE OFFICER OF VOLUSIA COUNTY AND WITH THE DEPARTMENT OF STATE; PROVIDING FOR CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.
