A. Call to Order & Roll Call

Members present: Donia Dewees, Cynthia Livingston, James W. (Buck) Carr, Debi Malphurs. Members absent: Joseph Ludwig, Jane Andrews, Paul Davis.

- B. Approval of the 7/9/2013 Minutes
 Vice Chair Cindy Livingston made a motion, seconded by Board Member Debi Malphurs, to accept the July minutes. Roll call vote: Vice Chair Cindy Livingston, Yes; Member Debi Malphurs, Yes; Member Buck Carr, Yes; Chair Donia Dewees, Yes. Motion carried, 4-0.
- C. Old Business
 - 1. EMC Divers' proposal for the City Commission Board Member Buck Carr received by Email attachment a proposal and quote from Jeff Landers of EMC Divers for restoring sand at Sunrise Park. The Email was forwarded to the City Clerk and to the Mayor for consideration as a City Commission agenda item. Board members agreed, however, that by now a lot of the sand has come back, and the need is questionable.
