PRESENTATION: Presentation to Councilor Shawn O'Neill upon his fourteen years of

service to the citizens of Old Orchard Beach and service on the Old Orchard Beach Town Council - 11/97 to 11/11 by Business Owner and Citizen George Kerr and Assistant Town Manager V. Louise Reid.

ASSISTANT TOWN MANAGER: Shawn O'Neill was one of the first individuals I met when I was hired as the Director of The Salvation Army Pavilion. MOTION: Vice Chair Tousignant motioned and Councilor Dayton seconded to Approve the Business Licenses as read.

VOTE: Unanimous.

TOWN MANAGER'S REPORT: Thanks to the Town Clerk and the election volunteers for an excellent job done during the election process. The Assistant Town Manager attended the American Legion's Veterans Day Ceremony and also the Christopher Cash Veterans Day Ceremony at the Memorial Park on Veterans Day. I have asked the RSU to address the unfinished project that will identify new property lines and new deeds for the school property. I am going to ask the Town Council at a subsequent meeting to amend the Ballpark Ordinance Section – Ballpark descriptions which currently includes the 49 acres of undeveloped land. The Ballpark commission and I feel the undeveloped property around the Stadium and the parking lot should be under the management of the Town Council as assisted by the Town Manager and Planner. It is my suggestion that the language include that the Ballpark Commission will be considered as working advisors in any further development. Intersection of Saco Avenue and Union Avenue project update will be given at the December 6th meeting by the Public Works Director who will explain the details. Be thinking about the \$60,000 plus possible short fall. Again, I encourage property owners and renters who think they may be eligible to apply for the State Circuit Breaker Program. (See attached sheet.) Last minute Union negotiations have been stressful and time consuming with both the Police and Public Works. Late evening changes in the Police Contract are leading me to request the Town Council to Table Indefinitely the Police Contract. Curt Koehler, Biddeford's Finance Director, has been helping us out in Finance. A public thank you to the City of Biddeford and Town Manager John Bubier. We sincerely appreciate Curt's work on nights and weekends. Ballpark Update - Have been attending meetings and we are addressing issues on lighting and other structural needs. Working on Grievances with the Attorney – Waste Water. Currently we have two vacancies – one at Waste Water – Retirement; and one at Public Works – tri-community involvement as a Camera Truck Operator.

NEW BUSINESS:

5519 Discussion with Action: Confirm and Approve a two year Employment Agreement for the position of Finance Director/Treasurer, at a salary of \$80,000, with a six month probationary period.

TOWN MANAGER: The Town Manager requested that the Town Council approve a two year Employment Agreement for the position of Finance Director/Treasurer, at a salary of \$80,000, with a six month probationary period for Catherine A. Saltz, CPA, MBA. She is a seasoned manager with extensive experience in finance, human resources, IT, marketing, Accounts Receivable, Accounts Payable, Customer Service, Cash Management Budgeting, Facility maintenance, Capital Projects, transportation and the general areas of operation of a company. She has served for seventeen years as a chief Financial Officer for various companies, including eleven years working in the non-profit sector. She has a working knowledge of governmental funding, reporting and regulations. She is currently the Finance Director for the Town of Kittery. She also is proficient in the MUNIS operation.

John Bird questioned the salary although he indicated he is sure the applicant is qualified. The Chair also indicated salary is a consideration but he recognized the urgency of the situation and the requirements needed in this important function. He also indicated that no increases in salaries to other employees would not be afforded the newly hired employees over the past few weeks. The applicant for Finance Director/Treasurer, Catherine A. Saltz, CPA, MBA, expressed appreciation to the Council for this opportunity and said she looks forward to being part of the community.

MOTION: Councilor O'Neill motioned and Vice Chair Tousignant seconded to Confirm and Approve a two-year Agreement for the position of Finance/Director/ Treasurer, at a salary of \$80,000, with a six-month probationary period.

VOTE: Unanimous.

5522 Discussion with Action: Approve and Accept a Resolution and Signage to Promote the Health, Wellness and Safety of the Town of Old Orchard Beach Residents and Visitors by advising against the usage of tobacco products on Old Orchard Beach municipal beaches.

BACKGROUND:

Two Workshops were held on the issue of smoking on the beach as promoted by local students. On November 1, 2011 the Town Council discussed the resolution passage and in particular thanks the young students for bringing this issue forward. A review of the resolution, however, caused concern about the verbiage of the heading of the Resolution which indicates the beach will be a TOBACCO-FREE ZONE and also verbiage within the Resolution which again indicates TOBACCO-FREE ZONE. Only at the very end of the resolution does it infer that this will be a voluntary decision which caused the concern of Vice Chair Tousignant that it was not a clear and proper promotion of the desire of the Council which was to encourage a TOBACCO-FREE ZONE but not indicate the beach was a TOBACCO-FREE ZONE.

The Chair has placed this item on the agenda again for consideration of the Town Council and also for consideration of the signage verbiage. The Agreement includes the word <u>Voluntary</u> as requested by the Council at the last Council meeting.

A RESOLUTION TO PROMOTE THE HEALTH, WELLNESS AND SAFETY OF THE TOWN OF OLD ORCHARD BEACH RESIDENTS AND VISITORS BY ESTABLISHING OLD ORCHARD BEACH MUNICIPAL BEACHES AS <u>VOLUNTARY</u> TOBACCO-FREE ZONES

Whereas the Town of Old Orchard Beach, Maine, cares deeply about promoting the good health, quality of life and clean environment for its citizens and visitors; and

Whereas tobacco use is the single most preventable cause of death and disease in the United States, as well as in Old Orchard Beach, Maine, leading to more deaths than most other leading causes combined (including AIDS, alcohol, illegal drugs, motor vehicle accidents, firearms, murders, suicides, and fires); and

Whereas secondhand smoke contains many harmful chemicals and cancer-causing agents, and is a serious health risk to humans, especially infants, children and pregnant women; and increases a non-smoker's risk for asthma, heart disease, lung cancer and related respiratory illnesses; and

Whereas the use of smokeless tobacco is associated with saliva, or spit being cast upon the ground, seating areas, and other surfaces in recreational areas, resulting in increased risk of nonusers being exposed to bacteria and viruses of a variety of respiratory illnesses; and

Whereas tobacco litter is the most littered item in the environment globally as well as in Old Orchard Beach, causing harm to humans, the environment, marine and other wildlife; and

Whereas tobacco use in and around the Town of Old Orchard Beach municipal beach facilities sends contradictory messages to young people in being encouraged to participate in outdoor activities beneficial to their health, while at the same time being exposed to the use of harmful tobacco products and secondhand smoke; and

Whereas the Town of Old Orchard Beach has a seven mile long stretch of coastline with beaches that draw visitors from all over Maine, the U.S. and other countries, it is the goal of the Town of Old Orchard Beach to provide recreational and leisure opportunities that enhance the quality of life for its citizens and visitors and provide a safe, clean and attractive environment, the Town of Old Orchard Beach has an obligation to advise against those activities which it deems contrary to this goal; and

NOW, THEREFORE BE IT RESOLVED, that the Town of Old Orchard Beach does hereby declare that its municipal beaches are <u>VOLUNTARY</u> tobacco-free zones and specifically discourages the use of any tobacco product, including, but not limited to cigarettes, cigars, and chewing tobacco, on, in or at any municipal beach area under the authority of the Town of Old Orchard Beach.

BE IT FURTHER RESOLVED, that the Town of Old Orchard Beach is authorized to take reasonable steps such as signage, tobacco litter receptacles and other education and communication tools to achieve voluntary compliance with the tobacco-free beach policy established hereunder.

Dear Town of Old Orchard Beach:

I am writing in support of a tobacco-free beach for Old Orchard Beach, Maine.

For the past several years I have spent hundreds of hours, volunteering to pick up tobacco liter at the Union Ave. entrance. I have submitted dozens of photo's and stats to all the town council members, town officials and chief of police demonstrating how big of a problem this is.

A tobacco-free policy sends a clear message that Old Orchard Beach cares about the health of the community, especially our youth. I believe that by making the town beach a tobacco free place; you will enhance revenues, increase tourism and make our community a healthier place to live and work. A smoke free beach also gives children another place where they don't see people smoking. They also avoid the danger of coming in contact with toxic cigarette waste.

FACT: Daily, thousands of cigarettes are flicked or dropped, one at a time, in Old Orchard Beach, Maine. Places you will see the nasty tobacco waste by the thousands are **on the beach**, town sidewalks, and other public areas. Tobacco waste on the beach has always been a "big" problem for the town, but this past spring/summer the problem is the worst I have seen. Below is what thousands of other beach goers observed in 2011.

- Daily children's sand castles and their sand pales' are littered with cigarette butts/they can't play in the sand without having contact with tobacco waste
- Daily children are picking up butts and playing with them, thinking they might be a seashell
- Daily tourists and local residents are forced to place their beach towels and/or beach chairs on top of disgusting tobacco waste. There isn't any place on the beach you can sit down without seeing cigarette butts. YUCK!!....
- Daily when you stroll the beach you step on dozens if not hundreds of toxic tobacco waste
- Daily tourists & locals are disgusted with the thousands of littered cigarette butts
- Daily thousands of cigarette butts are washed into the oceans, streams and storm drains; killing the fish/habitat and are polluting the waters
- Daily non-smokers and children are poisoned by second hand smoke
- The beach and the town of Old Orchard Beach, Maine is not a GIANT ASH TRAY, but lately it is hard to tell the difference if you visit the beach often

- 3. PLEASE DO NOT USE TOBACCO PRODUCTS ON OUR BEACH
