5548 Discussion with Action: Amend the Code of Ordinances, Division 2, Rules for Advisory Boards and Committees, Section 2-234 – Powers and Duties.

CHAIR QUINN: The Council will consider amending rules for Advisory Boards and Committees. At a previous Workshop the following changes were suggested but after a lengthy discussion it appeared that a consideration of interest was in two changes which are shown below those considered at the Public Hearing:

PUBLIC HEARING CONSIDERATIONS:

Sec. 2-234. Powers and duties.

- (a) The members of <u>an</u> advisory board, commission, or committee shall perform all of the duties as requested by the town council.
- (b) Each appointee shall be sworn by the town clerk.
- (c) The alternate members of each board, commission, or committee may participate in a meeting discussion and shall have the ability to vote only if a regular member is not present or there is not a quorum to convene a meeting.
- (d) The board, commission, or committee shall elect a chairperson first from among its regular members <u>annually by January 31st of each year</u> who shall be responsible for agendas.
- (e) The committee shall appoint a secretary from its members, who shall be sworn and who shall be responsible to submit minutes of any meeting to the town clerk within 30 days as well as a copy to the town manager.
- (f) No board, commission, or committee member shall serve as Chair, Vice Chair or Secretary for more than 2 consecutive years.
- (f) The town manager, department heads or council members shall not be appointed as regular or alternate members, nor may they serve as secretary to any board or committee.
- (g) No meeting shall be convened without a quorum consisting of at least three members. (Ord. of 6-16-1992, art. II, \S 1)

COUNCIL SHOWED SOME INTEREST IN CONSIDERING THESE CHANGES NOTED IN BLUE AND THESE CHANGES IN BLUE WERE ACCEPTED:

Sec. 2-234. Powers and duties.

- (a) The members of <u>an</u> advisory board, commission, or committee shall perform all of the duties <u>as</u> requested by the town council <u>and as may be required by State Law</u>.
- (b) Each appointee shall be sworn by the town clerk.
- (c) The alternate members of each board, commission, or committee may participate in a meeting discussion and shall have the ability to vote only if a regular member is not present or there is not a quorum to convene a meeting.
- (d) <u>As its first order of business at the first meeting of the year</u>, the board, commission, or committee shall elect a chairperson first from among its regular members who shall be responsible for agendas.
- (e) The committee shall appoint a secretary from its members, who shall be sworn and who shall be responsible to submit minutes of any meeting to the town clerk within 30 days as well as a copy to the town manager.
- (f) No board, commission, or committee member shall serve as Chair, Vice Chair or Secretary for more than 2 consecutive years.

- (f) The town manager, department heads or council members shall not be appointed as regular or alternate members, nor may they serve as secretary to any board or committee.
- (g) No meeting shall be convened without a quorum consisting of at least three members. (Ord. of 6-16-1992, art. II, \S 1)

It should be noted that John Bird brought into the Assistant Town Manager's office earlier in the day of the Council Meeting suggested changes which included the following outlined in green but they were discussed but not approved by Council.

Sec. 2-234. Powers and duties.

- (a) The members of <u>an</u> advisory board, commission, or committee shall perform all of the duties <u>as</u> requested by the town council <u>and as may be required by State Law</u> and the Town Charter.
- (b) Each appointee shall be sworn by the town clerk.
- (c) The alternate members of each board, commission, or committee may participate in a meeting discussion and shall have the ability to vote only if a regular member is not present or there is not otherwise a quorum to convene a meeting.
- (d) As its first order of business at the first meeting of the calendar year, the board, commission, or committee shall elect a chairperson first from among its regular members who shall be responsible for agendas. If there is no current chair, the Town Clerk shall convene said first meeting for the purpose of electing one.
- (e) The <u>board, commission or</u> committee shall appoint a secretary <u>who need not be</u> from its members, who shall be sworn and who shall be responsible to submit minutes of any meeting to the town clerk <u>as outlined in the Town</u> Charter <u>within 30 days</u> as well as a copy to the town manager.
- (f) No board, commission, or committee member shall serve as Chair, Vice Chair or Secretary for more than 2 consecutive years.
- (f) The town manager, department heads or council members shall not be appointed as regular or alternate members, nor may they serve as secretary to any board or committee <u>except</u> as directed by Town Council.
- (g) No meeting shall be convened without a quorum consisting of at least three members. however a smaller number may adjourn the meeting to a new time, date, and/or place. At least 24 hours' notice of the date, time and place of holding such adjourned meeting shall be given to all members who were not present at the meeting from which adjournment was taken. (Ord. of 6-16-1992, art. II, § 1)

#5549 Discussion with Action: Amend the designation of the two parking spaces in front of 16 Old Orchard Street (205-5-5) from Taxi Stands to a Narrator Tour Trolley stop from 10 a.m. to 4 p.m. and Taxi Stands from 4 p.m. to 10 a.m., pursuant to Section 54-147 of the Traffic and Vehicles Ordinance.

TOWN MANAGER: The Biddeford Saco Old Orchard Transit Company (Shuttlebus) of which the Town of Old Orchard Beach, along with Saco and Biddeford, sponsor each year has decided to institute a narrated tour trolley this coming summer. The trolley (Robbie – named after the Assistant Town Manager's grandson) will do narrated tours through historical Old Orchard Beach, Ocean Park and the Campgrounds highlighting the many exciting historical accounts of the past. Bob Moody of Shuttlebus and Dan Blaney our Town Historian and Archivist have put their talents together to get this great idea off the ground. The amending of the parking spaces will permit parking concerns to be addressed. The Chief of Police has reviewed the plan and signed off on it. Ouestions were asked by Council members pertaining to any conflict with unloading of trucks for deliveries and also the dislocation of any taxi needing to park there during the day time hours. It was noted that most taxi parking there is late evening when the bars are closing but it will be monitored and any adjustments that are necessary will be made. The Code Enforcement Officer will inform the Taxi services of the change in parking hours. Jerome Begert indicated that he felt this type of narrated tour will be exceptional for the Town and that the history of our community is exciting for those who live here and visit here as well. The cost of the narrated tour may be considered between \$8 and \$10 and it was noted by Bob Moody that the charge in other towns is considerably more. This is being evaluated as they prepare for the coming summer tourist trade.

He described some of the activities and fundraising events that will take place during the observance this summer. Councilor Coleman spoke highly of the aims and objectives of this Run for the Fallen Maine and encouraged citizens to become involved.
