- Whereas, Many of our elderly, our disabled and those on fixed incomes are finding it increasingly difficult to pay their bills; and
- Whereas, Our food shelters and food pantries are finding it increasingly difficult to feed the rising number of people who are in need; while many of our community's children experience hunger as a daily reality in their lives; and

Whereas, The face of hunger is often invisible and hiding in the shadows; and the stigma of poverty represses and inhibits the ability to achieve success and personal growth, while eroding self-esteem and personal relationships;

Now therefore. We the people of Old Orchard Beach, in collaboration with our neighbors in the cities of Biddeford and Saco, wanting to call attention to those among us who feel the fear and pain of daily hunger, and desiring to educate all citizens about the existence of food insecurity within our community, and hoping to raise awareness of the plight of our local food pantries and social service agencies, officially declare the week of May 18<sup>th</sup> to the 24<sup>th</sup> as Hunger Awareness Week, and all citizens are urged to actively participate in activities and goals that help to reduce and eliminate hunger and poverty and their social and psychological effects with our community.

He met with the Ballpark Chair and Vice Chair as well as John and Pam Gallo regarding their one year contract extension. The Gallo's provided their proposed terms to which he will respond. The proposed contract will be reviewed by the Ballpark Commission for their recommendations prior to being presented to the Council for approval.

He and the Finance Director met with the Chair of RSU 23. Chairman Curtis discussed the RSU's budget status and withdrawal status.

# 5910 Discussion: Presentation on the proposed changes to FEMA's Flood Maps by Robert G. Gerber (P.E., C.G., P.G.) – Senior Engineer/Geologist Town Manager from Ransom Consulting Inc. Robert Peabody

The Chair said she asked Robert G Gerber to present a quick overview so that the Council could take time to review his material and be prepared for a workshop on this item.

Last time the maps were done was in 1985. They try to do every 20 years. This process started in 2006. In 2009 they came out with the preliminary maps. The appeal period came and went as several cities challenge the maps so they started all over again in 2010. In February they gave us a work map. (he gave the Council copies). The existing zones are in orange and red. The yellow zone shows the new flood zone. The next version of the map is due out the end of May. He said we may want to challenge that. There will be one meeting for the county. He said the insurance issue for this are huge. He said the rates would be going up about 20% a year. We can't let the appeal deadline go by.

The Chair asked Jim Butler to get a timeline to the Council. There will be a workshop after they get the maps from FEMA. She asked the Town Manager to get with other towns to join forces in the fight. Councilor Dayton asked if the Town has a contract with Mr. Geber. He said yes, it is in conjunction with 12 towns total. It is about \$250 quarterly. Council Dayton asked for a copy of the contract.

Mike Fortunado, a member of the Board of Directors at the Condominium Assoc. spoke and said he could answer any questions this evening. He said he sent a letter 4 25 to the Council. There was discussion about the wording being wrong. Mike said the bond money would be used for gates that have been ordered. Councilor Mailhot said she doesn't have a copy. Mike gave her one.

Vice Chair Bolduc said her understanding was that the money was to be used to offset the Town's legal fees. The Chair and Councilor Coleman agreed with that understanding. Councilor Coleman asked how much they had left to finish the project... Mike said about \$150,000. Vice Chair Bolduc said that since that last meeting it was brought to her attention that the previous Town Manager had adjusted some forms. She thought we should Workshop this. Mike said this falls on the shoulders of the Town. He said money was released to the developer without inspecting that the work had been completed. Councilor Mailhot said the reason she was looking for answers was to protect the town. Mr. Fortunado doesn't think the Town has the right to the money. This has been going on for nine years. This money was deducted from the performance bond. Councilor Coleman said that without the Town going against issue there would not be any money at all. The \$4,956.25 was the cost of going after the \$18,000. Mr. Fortunado said two years ago Code Enforcement didn't do their job. He also said \$2000 was taken out for an assessment. Councilor Quinn said he had asked Jeffery H if we could keep that money. Councilor Quinn thinks we need to ask Jeffery if he got an opinion. The Chair said in an Executive Session the attorney was asked and he said they could take the legal fee out of the bond.

Councilor Mailhot asked for the Town Clerk to give timeframes so all are clear. Kim said the election should take place between June 11<sup>th</sup> and June 21<sup>st</sup>. Kim said they needed the set the dates of when the nomination papers would be available. She suggested the 10<sup>th</sup> to the 20<sup>th</sup>. State law requires 10 days

Vice Chair Bolduc wanted to let the general public know that we have a lot of work to do but we need to focus of the fact that this is a government process. She apologized to anyone that was there tonight because they had heard that the "Gang of Four" was going to try to delay the election. She said please feel free to her directly if they had any questions because there were so many innuendos and untruths out there.

Mr. Quinn asked Kim if there were any other issues. She said they could set the time regarding absentee ballots. She has checked to see if she could get the ballots earlier. She has worked with RSU to make sure all is okay. The cost to FedEx the ballots overnight could be about \$200. Kim is working her hardest to get extra time for the absentee ballots.

Chief Kelley said they need to decide where the machines are going to be. We will be getting 4 machines. Two for this year and two for next year but we will pay for two out of this years budget and two from next years budget. Vice Chair Bolduc said her recollection was 1 at Memorial Park and 3 at Milliken.

A member of the audience got up and she said we are not attracting people because of the parking and trash pick up issues. The Chair explained that they were discussing the town lots. They have no say over private lots. Vice Chair Bolduc said that although the new machines cost a lot they will help the issue of folks coming early and not paying at all. Councilor Mailhot asked about the fees for the using debit cards. Mike Tousignant asked why three in Milliken St. He said we have enough now to buy three. That should be enough. Councilor Coleman said adding the convenience fee to the user would make us the only ones anywhere to do that. He said the use of them alone more often will bring in more money. The Chief said the reason for three at Milliken was to not have people walk so far. Vice Chair Bolduc asked how difficult it would be to move the machine if we found if more efficient to do so. The Chief said they are solar powered so there would not be an issue. Councilor Furtado suggested they put them at the entry way. The Chief said the machines are more complicated than just driving through.

Paul Golzbein said this should be tried out without spending money you don't have. Pat Brown thought Councilor Furtado's idea was good. She also agreed that only two were needed. Councilor Dayton said she was not in favor of any machines. She favors giving jobs to locals. She liked the human aspect. Mike Tousignant got up again and Councilor Coleman questioned the rule of one time up. Mike said they should have stated that before the meeting started. He said he agreed with Dana. He said it sounds like we are \$2000 short of buying three machines. He said we have overspent to the tune of over \$400,000. This has got to stop. He said Milliken has a short use span. Only 6 weeks. At the workshop he saw nothing spoken about revenue. He said stop spending money you don't have. Harold got up and said he would donate the \$2000 so they could buy 3 machines.

Motion to purchase three, placing one at the Memorial Park parking lot and two at the Milliken Street parking lot and thanking the donation of \$2000 and the balance come out of the CIP noted Councilor Coleman Seconded Councilor Quinn The Chair said she didn't think the donation was appropriate, the Vice Chair agreed. Councilor Mailhot asked if the merchant fees had been decided yet. Councilor Coleman said he stated no other municipality does that. It would look cheap. Mike Tousignant wanted to clarify that Milliken Street is not a 24 hour lot. Vice Chair Bolduc asked if the cost of the machines would go up if we only bought three machines. The Chief said no.

# GOOD AND WELFARE:

Paul Golzbein said he was ashamed of the Council. This has got to stop. This is supose to be a fun town. He is embarrassed.

Anita Rousseau said she is humiliated in this town. She feels Old Orchard is against people trying to make a business. They tried opening Scooter ETC Corp. They came to town hall and were told they could take the money for the taxes but that the owners had to go to Portland because it was too more paperwork for the town to register the 6 scooters. The way they were treated was not nice. They also wanted to rent a house out and were told they needed new windows. She said she has seen many houses with the same windows they now have. They said they talked to Jeffery about opening a food service and Jeffrey said they could as long as they weren't open 7 days a week. Later they ran into him and he said they had to close down by Thursday. He has tried to call Jeffrey several times and hasn't gotten a call back. They called Kathy several times and didn't get a call back. She finally did call them and said they need to close Wednesday. He is going to see Jeffrey Monday. He said other businesses have gotten raided by the FBI, the TEA, the State Police and their licenses are still good? He is doing everything by the book. The Chair said bringing it to them attention was good. She asked the Manager to get involved in the meeting with Jeffrey and keep the Council updated. The manager said the issue is a zoning issue but he will get involved. The Chair said this is the third excise tax issue she has heard of and would like that looked into. They cleared up that they paid the tax; it was the vehicle registration that couldn't be done.

Robin Dube suggested they opened up more spaces on Main Street for motorcycles.

Mike Tousignant came up and asked the Councilors to move their cell phones to see if it would make the buzz stop. The real issue he came was because of the FEMA map thing. The implications of these changes are huge. He thinks all those involved should be sent a letter. He said some folks are spending \$300 or \$400 a month in insurance. He said it will take one big fight to fight it but it needs to be done.

Jerome Begert talked about the Charter. He talked about Recall4 using the Charter to fake credibility. He explained "no cause" and said that is a breach of the Charter. He went on to give examples such as fire fighters being told to sign some petitions and not others. He also said the Hatch Act was violated by several people. He also talked about the whistle blower law and disability law.

Dave Francore said this discussion is not appropriate. He requested that the behavior not be allowed to continue.
