

PROPOSED AMENDMENTS
TO THE

The Old Saybrook Conservation Commission does hereby petition that the following amendments be made to the Old Saybrook Inland Wetlands Regulations. Proposed additions are underscored.

SECTION 2. DEFINITIONS

“Wetlands or watercourses” includes aquatic, plant or animal life and habitats in wetlands or watercourses.


“Habitats” means areas or environments in which an organism or biological population normally lives or occurs.

SECTION 10. CONSIDERATIONS FOR DECISION

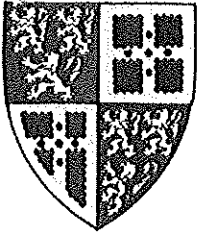
{Add new Section 10.3 and renumber current sections accordingly.}

10.3 A municipal inland wetlands agency shall not deny or condition an application for a regulated activity in an area outside wetlands or watercourses on the basis of an impact or effect on aquatic, plant, or animal life unless such activity will likely impact or affect the physical characteristics of such wetlands or watercourses.

The Inland Wetlands & Watercourses Commission of the Town of Old Saybrook, Connecticut granted a petition to amend the Inland Wetlands Regulations at a regular meeting on Thursday, November 18, 2004 7:30 p.m. at Pasbeshauke Pavilion, 155 College Street Extension:

AMENDMENTS TO THE OLD SAYBROOK INLAND WETLANDS & WATERCOURSES REGULATIONS

Section 2, Definitions: Proposal to add a definition of 1) "wetlands and watercourses" to include aquatic, plant or animal life and habitats in wetlands or watercourses and 2) "habitats" to include areas or environments in which an organism or biological population normally lives

Section 10, Considerations for Decisions: Proposal includes adding a new section (10.3) to allow the Commission to deny an application for a regulated activity outside of the wetlands if the activity will impact or affect the physical characteristics of the wetlands.
