MINUTES OF THE PUBLIC HEARING October 29, 1992

RE: The application of Stephen and Lynne Wardlaw, of 191 North Cove Road, for the Certificate of Appropriateness for the construction of a fence at that location.

Members Present: J. Schneider, Acting Chair; H. David, E. David.

The Public Hearing was called to order at 8:07 P.M. E. David, Clerk, read the legal notice of the hearing which appeared in <u>The Pictorial</u> on October 17 and October 24.

As the purpose of the hearing was to review the application of Stephen and Lynne Wardlaw for a Certificate of Appropriateness for the construction of a fence at 191 North Cove Road, S. Wardlaw excused himself from his official capacity and turned the meeting over to J. Schneider.

- S. Wardlaw presented the plans for the construction of a natural wood stockade fence along his property line adjacent to the public right of way. Discussion included the height of the fence (maximum allowed 6') and the treatment of the termination of the fence which will be approximately at the earth berm. Suggestions were made for softening the termination of the fence, making it visually appealing from both land and water.
- J. Schneider moved and H. David seconded the closure of the Public Hearing at 8:30 P.M.

The Special Meeting of the Commission was held immediately following the Public Hearing. After discussion, J. Schneider moved that:

The Certificate of Appropriateness be granted to Stephen and Lynne Wardlaw for the plans as submitted, subject to the modifications suggested during the public hearing.
