I. CALL TO ORDER: Chairman Randi Bradbury called the meeting to order at 7:05 p.m.

III. PUBLIC HEARING

A. APPLICATION FOR CERTIFICATE OF APPROPRIATENESS

55 North Cove Road, Stonewall

Applicant: Barbara Genther

Applicant proposes addition to existing stonewall, 20"H x 18"D x 25'L, materials will match existing. Discussion with respect to the public hearing that closed this evening The public was asked for comments. P. Connolly spoke in favor of the application. No one opposed.

A **Motion** was made by R. Welsh, seconded by K. Dubuc to **GRANT** Certificate of Appropriateness to Barbara Genther as the stonewall will improve aesthetics and safety of area. No discussion and a vote was taken: In favor: R Bradbury, J. Foisie, R. Welsh, K. Dubuc, L. Tietjen. Opposed: None. Abstaining: None The motion passed unanimously. 5-0-0 Public hearing closed.

IV. OLD BUSINESS:

1.) L. LEE RESIDENCE, cont.

2003 at a location and time to be determined. No discussion and a vote was taken: In favor: R Bradbury, J. Foisie, R. Welsh, L. Tietjen. Opposed: None. Abstaining: K. Dubuc The motion passed. 4-0-1

2.) REGULATIONS REVIEW

K. Dubuc reseated.

Atty. Cronin distributed updated regulations to Commissioners for review. The changes made to the regulations serve to eliminate inconsistencies with the State Statutes which they are meant to reflect. The following modifications were made to this document:

Section 1: add <u>action</u> of hearing applications to clarify Commissioners duties for handbook readers. Section 1 will remain *Purpose of District*, a Section 2 will be added titled *Duties of Commissioners*. Remaining numbered sections are renumbered accordingly.

Definitions- (now Section 3) changes reflect definitions used in state statutes.

Section 4- changes reflect wording

Section 5- discussion regarding requirements for applications a result of this discussion, the following changes were made on the *updated* regulations:

- eliminate second part of sentence in "a". used in state statutes
- all number of copies in "1." Through "8." become 8 to be consistent.

Section 6- a. Clerk will check box every Friday and stamp application RECEIVED on that date which will stand as the beginning of the 65 day application process calendar.

Section 8- reworked to incorporate specific statuatory language. One paragraph has been broken down in to three categories: structure, neighborhood and parking.

Section 10- modified to add statuatory reference. R. Bradbury suggests referring statute # in NCHDC regulations.

Section 11- fines will be incorporated into this section

Section 13- Atty. Cronin will check for consistency. Regulation changes will need to be filed with Town Clerk. Robert Welsh leaves meeting at 8:30, P. Osbourne is seated presently.

ACTION: At a future meeting of the NCHDC a Public Hearing date will be set to accept regulations.

3.) HARBOR MANAGEMENT REVIEW

Atty. Cronin informed the commission that the Harbo Management planis ready for informal Public Haering in October. tHe plan has been approved by the DEP and will go to Town Meeting the end of november where it will either be accepted or rejected. The issues include moorings and docks construction. NCHDC can comment collectively or individually at the Town meeting. If any Commissioners would like to obtain a copy of the draft, it is available in the Land Use Department at the Town Hall.

ACTION: At a future meeting of the NCHDC a Public Hearing date will be set to accept regulations

4.) NCHDC HANDBOOK

Discussion regarding handbook development.

A **Motion** was made by R. Bradbury, seconded by P. Osborne to hold Handbook Workshop at the next regular business meeting at a date to be determined. No discussion and a vote was taken: In favor: R

ACTION: Develop agenda for a Handbook Workshop which will be held at the next regular meeting of the NCHDC.

A. STATUS OF TULLY HOUSE

Donna DiBella, 91 North Cove Road, inquired about status of Tully House and what agency would have information regarding same. NCHDC has no further involvement with project until it is completed and the renovations are checked against the drawings submitted on the application. Discussion followed.

A **Motion** was made by R. Bradbury, seconded by P. Osborne to send letter of inquiry to State Historical Commission regarding status on Tully House. No discussion and a vote was taken: In favor: R Bradbury, J. Foisie, K. Dubuc, L. Tietjen, P. Osborne. Opposed: None. Abstaining: None. The motion passed unanimously. 5-0-0

ACTION: R. Bradbury will write letter to State Historic Commission regarding status of Tully House.
