#### III. PUBLIC HEARING

R. Bradbury recused. H. David seated. Public notice was read into minutes.

## A. APPLICATION FOR CERTIFICATE OF APPROPRIATENESS

61 Cromwell Place, Playscape Installation

Applicant: Carter Gowrie

Applicant proposes installation of freestanding playscape in southeast corner of yard on subject property

Discussion followed with respect to the public hearing that closed this evening. The public was asked for comments. No one spoke in favor of the application. No one opposed.

A **Motion** was made by H. David, seconded by R. Morrison to **GRANT** Certificate of Appropriateness to Carter Gowrie as the playscape installation will not interfere with the aesthetics of the area due to the location of the playscape in the southeast corner. - 3.) ELECTION OF OFFICERS Chairman read letter of recognition for Janet Foisie's service to Commission. Robert Wendler has been appointed to replace J. Foisie. Mr. Wendler is an architect who was an original member of the Survey Committee when the District first was designated.
- R. Welsh nominated R. Bradbury for Chairman. A **Motion** was made by R. Welsh, seconded by K. Dubuc to elect Randi Bradbury for the Chairman of the NCHDC for the 2004 year. No discussion and a vote was taken: In favor: R Welsh, R. Morrison, K. Dubuc, R. Wendler and H. David. Opposed: None. Abstaining: R. Bradbury. The motion passed unanimously. 4-0-1
- R. Bradbury nominated R. Welsh for Vice Chairman. A **Motion** was made by R. Bradbury, seconded by R. Wendler to elect Robert Welsh for the Vice Chairman of the NCHDC for the 2004 year. No discussion and a vote was taken: In favor:, R. Bradbury, R. Morrison, K. Dubuc, R. Wendler and H. David. Opposed: None. Abstaining: R. Welsh. The motion passed unanimously. 4-0-1
- R. Welsh nominated R. Morrison for Secretary. A **Motion** was made by R. Welsh, seconded by R. Bradbury to elect Richard Morrison for the Secretary of the NCHDC for the 2004 year. No discussion and a vote was taken: In favor:, R. Bradbury, R Welsh, K. Dubuc, R. Wendler and H. David. Opposed: None. Abstaining: R. Morrison. The motion passed unanimously. 4-0-1

- **4.) MEDIA COMMUNICATIONS** Discussion took place regarding members of the NCHDC communicating with the media on applications and/or commission news. It was determined that the Chairperson only would discuss applications and news with the media. Members cannot discuss application outside of Public Hearing with other members of the Commission, the public or the media.
- 5.) NCHDC JURISDICTION OVER STRUCTURE OF HISTORIC HOME R. Morrison concerned with enforcement of interior of home regarding structure/maintenance of home to prevent demolition. Discussion followed. It was determined that according to State Statues the commission is limited to reviewing the exterior of the home only. There is also a difficulty in addressing the issue of structural integrity of the home due to the fact that decomposition of internal support systems cannot be determined until well after work has begun and interior finishes have been removed. The opportunity to educate the public about this issue will take place in the handbook. Resources should be provided that can educate the public regarding the importance of maintenance schedules and any tax incentives available to homeowner. R. Morrison will report on resources available and tax incentives for homeowners to restore and/or maintain historic property. Discussion then turned to question of how a property i designated as historic. Clerk will bring *Cultural Resource Index* to next meeting for members to peruse. *Planning*

for Historic Preservation handout has much information regarding the aforementioned topics and is a valuable tool for Commissioners to read and have on hand at meetings.

6.) MAILINGS TO DISTRICT RESIDENTS Mailings have been taking place to district residents informing them of meetings as a courtesy (not required).
