III. REGULAR BUSINESS:

a. Member Reports - District Handbook.

R. Wendler reported on the map of the district as prepared by Christine Nelson, Town Planner. Discussion was held regarding layout of the map and corrections to be made to include the addition of numbers on the contributing houses and elimination of two properties that lie outside the district. R. Wendler will speak with the Town Planner to arrange for those corrections to be made. R. Bradbury will research the cost to have the map enlarged for use at Public Hearings.

Further discussion was held regarding the placement of a photograph of one of the district's contributing houses on the cover of the NCHDC handbook. Motion to have R. Bradbury write a letter to Jean Cowles, 175 North Cove Road (Black Horse Tavern) in order to seek permission to photograph her property for the cover of the NCHDC handbook made by H. David, seconded by P. Osbourne. No further discussion and a vote was taken. In favor: R. Bradbury, H. David, P. Osbourne, R. Welsh and R. Wendler. Opposed: None. Abstaining: None. - (3) Discussion of tax abatement questions to be researched by R. Morrison. Consensus of NCHDC members present that production of handbook should not be delayed subject to completion of the tax abatement research. R. Bradbury will contact R. Morrison for an update.
