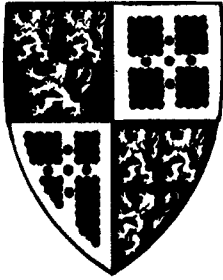
Congratulations on your grant award. Governor Rell and I look forward to working with you to continue to improve the well being of Connecticut's communities in the future.

Dear Ray:

I want to let the Harbor Commission know how appreciative I am both officially from my Selectman position and personally as a North Cove mooring holder for the efforts of Scott Mitchell, the Town's Dock Master.

As a North Cove mooring holder I received the email from Scott prior to the storm asking all vessel owners to secure their vessels for the pending hurricane. I understand Scott followed up on his email by personally checking all the moorings in North Cove for two pennants, and took action to secure any vessel not appropriately prepared. Thankfully the result was there was little or no damage to vessels moored in North Cove which is remarkable for a storm such as we experienced.

I have also been told that Scott identified storm damage issues at the Ferry Dock and took the initiative to contact you in your role as Chairman to get authority to purchase necessary supplies for emergency repairs. He then proceeded with and completed the required repairs to make the facility usable.

As Selectman I appreciate Scott's concern for the safety and well-being of the slip owners at Ferry Dock, as well as his efforts to keep damage to a minimum in North Cove. I believe the Commission made a good choice when hiring Scott to the Dock Master position. His ongoing efforts and diligence are to be commended.
