IV. PRESENTATION

"The Good, The Bad & The Ugly" Legal Considerations in Design & Aesthetics

Presenter: Mark K. Branse, Esq., Branse, Willis & Knapp, LLC

Ms. Nelson introduced the presenter, Mark Branse, Esq., and explained that the purpose of the presentation was to have a better understanding of what can be legally regulated by the Commission. Atty. Branse showed a PowerPoint presentation of examples of buildings, signs, parking areas and landscapes of commercial settings from various towns. The Commission viewed examples of architecture in line with the goals of towns that maintain New England quaintness, as well as others that were considered less appealing.

Discussion followed pertaining to the shortage of parking in certain areas of Town. Ideas for additional parking were mentioned, although there are no definite plans at this time.

Mr. Talbott presented photos of business vehicles that are being used as signs and seem to be permanently parked in front of businesses. The Commission discussed the legality of such practices.

Mr. Friedmann inquired about a policy on electronic signs that flash more frequently than every 15 minutes. Atty. Branse recommended it be put in the Zoning Regulations. Mr. Friedmann also questioned the wording of signs and if they must be used solely for the name of the business. Atty. Branse clarified that businesses can word their signs for advertisements, rather than the business name, as long as they stay within the size limits. He also commented on the aesthetic appeal of some businesses that have dressed up their rear entrances with signs and awnings.

Ms. Nelson gave credit to the Commission for creating regulations that additionally serve as design standards. She suggested that the Commission review the standards to see if they still are in line with the desired effects on the community. Atty. Branse suggested that Commission members take photos of signs they either liked or disliked and analyze the constraints of the signs to quantify the characteristics and aid in designing standards.

V. COMMITTEE, REPRESENTATIVE & STAFF REPORTS

ZEO Costa reported on the following:

 A letter was received from Gray Sobran requesting to operate a wholesale marine business at 71 Mill Rock Road East. The Commission determined that this is a marine commercial use and is not an allowable use in the Business B-4 district.

- Dr. David Morandt, 1358 Boston Post Road sent a letter requesting that the Commission remove Special Exception Permit requirements for sidewalks on Boston Post and Old Post Roads. The Commission determined that this is a modification of the approved Special Exception Permit.
- The Commission was updated on anticipated applications for upcoming meetings including workshops to be held the second meeting of every month depending on application workload.
