A. "The Preserve" Special Exception for Open Space Subdivision (934 ac. total) & Open Space (542.2 ac.)

Ingham Hill and Bokum Roads (Map 55, 56 & 61 / Lots 6, 3, 15, 17, 18)

Residence Conservation C District, Aquifer Protection Area

Applicant: River Sound Development LLC Agent: Robert A. Landino, P.E.

Chairman Mc Intyre called the site walk meeting to order at about 10:10 and introduced Atty. Willis who gave the "rules of site walk". Attorney Royston, representing the property owner, gave a list of requests for the site walk. Dennis Goderre oriented the

group by way of a map (presented as an exhibit) and then led the group on the site walk, which began near the terminus of the paved portion of Ingham Hill Road, passing proposed golf course holes #10 and #16 and the Pequot Swamp, continuing to the area where the Central Village is proposed, and ending along Road A toward the East Village. Mr. Goderre indicated where the water tower is proposed and where the Clubhouse would be. The group returned using the same route to the Ingham Hill Road starting point.
