NOTICE OF DECISION OLD SAYBROOK PLANNING COMMISSION

The following action was taken at the March 23, 2005 Special Meeting of the Old Saybrook Planning Commission:

Application for a Special Exception for an Open Space Subdivision Plan filed by River Sound Development, LLC, for Property located at Assessor's Map 56, Lot 6, Map 55, Lot 3 and Map 61, Lot 15 - 17 - 18, Ingham Hill Road - Bokum Road, Old Saybrook. Preliminary open space subdivision plan within the Residence C, Conservation District. Decision: APPROVED with conditions and restrictions, on a vote of 4-1. Modifications included, but were not limited to: (a) making the access from Road H to Ingham Hill Road a full public roadway; (b) realigning Ingham Hill Road at the north end across proposed Lots 73 and 79; (c) modifying the golf course design to prohibit golf holes from crossing any portion of Pequot Swamp; (d) requiring a 100 foot horizontal natural undisturbed buffer surrounding the entire swamp to be included in the publicly-owned open space; (e) requiring a buffer of at least 180 feet in width to connect Vernal Pool #18 to the red maple swamp to the west of it; (f) installation of signs within the golf course prohibiting entry to adjacent natural areas to retrieve errant balls; (g) prohibiting clearing within 50 feet of identified vernal pools for the construction of the golf course; (h) requiring a level area for active recreation of at least 10 acres; (i) relocation of the maintenance facility; and (j) requiring plans for improvements to Ingham Hill Road and Bokum Road to address traffic burdens created by the subdivision.
