Meeting called to order at 6:30 p.m.

**Orleans Firebirds**, Eldredge Park, represented by John Kaletski. Proposes sign on back of dugout. Sign – 1.25' x 12', lettering – black, Firebirds logo – yellow and red. Sign will be installed on June 1<sup>st</sup> and removed September 1<sup>st</sup>. Letters will be mounted on clear lexan. **Pat made a motion to approve as presented "Home of the Orleans Firebirds". Cynthia seconded and the vote was 5-0-0.**

**Finbar's Landing**, 5 Rte. 6A, represented by Mark Powers. Is applying for metal roof color change - "wooden swing"; two roof signs - white background, blue lettering – 30" x 80", red background – white lettering, teardrop shape – white background. Logo – blue, yellow, brown – 56" x 36". **Will made a motion to approve as presented. Carolyn seconded and the vote was 5-0-0.**

**Orleans Fire Station**, 58 Eldredge Park Way, represented by Chief Quinn. Proposes reroofing fire station with architect style shingle, color – slate blende. **Cynthia made a motion to approve as presented. Pat seconded and the vote was 5-0-0.**

**A Stitch in Thyme**, 2 Academy Place, represented by Daphne Landers Marino. Proposes **ladder sign** – colors – black, graphite, dove gray, and titanium – 20 x 36" – 5 sq ft. **Building sign** above bay window – same colors, 12" x 74" = 6'1 sq ft. **Above door sign** – 26" x 46" = 8.3 sq ft. – same colors. **Carolyn made a motion to approve as submitted. Cynthia seconded and the vote was 5-0-0. If applicant decides to light any of the signs she needs to be in compliance with the town ordinances which are available online.**

**OLD/NEW BUSINESS**

**Gerry made a motion to approve the minutes of the May 12, 2011 meeting minutes. Carolyn seconded and the vote was 5-0-0.**
