A response from Atty. General's Office was received in regards to Mr. Osterberg's complaint of the Open Meeting Law. Executive Session minutes can be release once the reason for going into executive session has lapsed. The Town Council has determined that Abatement and Exemption applications are private documents so, therefore, current executive session minutes that deal with abatements and exemptions applications will not be released, or redacted before release. The Board agrees with this opinion. The Board notes a Q&A website, and Ken Hull will send a link to the Board members.
