The Board asked that Lou Briganti prepare a power point presentation about the Total Coliform/Groundwater Rules for the Board of Selectmen in November with a recommendation to not supply bottled water to the residents of Orleans during a boil water emergency.

The Orleans Water department will prepare a letter for meter pit owners to inform them of their liability as a pit owner and inform them of the new meter pit monitors for detecting leaks. The Board suggested that the letter be placed as a bill insert to save money.
