MINUTES

On a motion by Leonard Short seconded by Kenneth McKusick the Board voted to approve the minutes of the meeting of September 19, 2012 as written. The vote by the Board was 5-0-0.

WATER DEPARTMENT REPORT

TANK #2 PAINTING AND REHABILITATION

A robotic painting device fell on the inside of the tank causing minor damage to the floor of the tank and creating time loss while waiting for replacement parts for the robot. No injuries resulted from this accident. The painting is still scheduled to be completed by the of November. end

OLD BUSINESS

RFP STRATEGIC PLANNING/ASSET & FACILITIES MANAGEMENT

The Board was presented with revised final draft copy of the proposed RFP for an asset management plan for the Orleans Water Department. The Board made some additional minor adjustments to the RFP.

A motion was made by Kenneth McKusick and seconded by Judith Bruce to approve the Asset Management Plan with edits. The vote by the Board was 5-0-0.

CHAPTER 158 WATER DEPARTMENT BYLAWS REVISION

The Chapter 158 Water Department Bylaws were revised to include updated model bylaws from MassDEP regarding Water Conservation and Cross Connection Control. The Board reviewed the proposed revisions and made some minor changes and asked that the revision with changes be brought back for the next regular meeting of the Board.

The Board had previously voted to calculate the usage from the 8/1/2012 water bill at the lowest rate at their meeting of September 5, 2012. The vote by the Board was 5-0-0.
