**Election of Chairperson, Vice Chairperson and Clerk:**

A motion was made to elect Judi Weil for Chairperson, Pat Bradley for Vice Chairperson and Eric Ehnstrom for Clerk. Motion was seconded and passed 4-0-0.

**Review/Update Action Items:**

**137: Roadway Master Plan:**

Judi discussed Town Administrator John Kelly's reply to her e-mail questions regarding: (1) the possibility of "sharrows" being painted in key locations around town at the time of striping; (2) the possibility of adding "fog lines" on Monument Rd. at the time of striping; (3) whether or not the committee could send an informal letter to Monument Rd. abutters to discern interest in widening the road before paving; and (4) the legality of voting on committee matters by e-mail.

Mr. Kelly deferred to the Traffic Study Committee on (1) and (2); discussed the possible legal research, survey work plus excavation and material expenses regarding (3); and advised the committee to only vote on matters with a quorum and at an advertised meeting (4).

Two motions were then made to send the following recommendations to the Traffic Study Committee: (1) the painting of "sharrows" on Monument Rd., Beach Rd., Rock Harbor Rd. and West Rd. by Salty Ridge (for directional purposes) and (2) the painting of "fog lines" on Monument Rd. when the striping is done following the new paving. The motion was seconded and passed 4-0-0.


