  - g. Historic Videos (Catherine Hertz) Funds are almost used up, but the project is not finished. Tom Cronin, from American Heritage Realty, has agreed to underwrite the balance of the project.

  - Hinckley Affordable Housing (Catherine Hertz) Per an email from George Meservey, this has been appealed to Land Court. McShane Construction is still on board.
  - j. Condominium Purchase (Harry Herrick) Harry will check with George Meservey regarding the RFP. Jane Hinckley stated that the Housing Committee will meet the second week in April.
  - k. Vocalion Catherine Hertz reported that their newsletter mentioned fund raising for the organ and also major fund raising for painting the building. Alan McClennen volunteered to be monitor of this project.
