Academy – Phases II & III (Jon Holt) – Jon attended an Academy meeting. He said the Committee should think about putting a deadline on this project.

Open Space (Alan McClennen) – It appears that an additional eight acres in Orleans will be preserved without any additional public money.

OHS Land and Septic Survey (Bill Garner) - No new information.

Putnam Farm (Catherine Hertz) – Alan reported that John Janelle has found the old well point and has papers to try to get power back to the site.

Namskaket Road Housing (Julia Enroth) – Board of Appeals have approved 40b comprehensive permit. RFP for a historic house is being prepared. Jon Holt reported that Habitat gave an award to Affordable Housing. Jon said the award belongs to many committees that did a lot of work to get this project done.

Odd Fellows Hall Restoration – Phase V (Sue Christie) – Paul Davies has signed the letter of agreement, thereby activating this project. There was a discussion regarding the last grant and the compelling need for the Odd Fellows to be placed on the historic register. Paul Davies said they need funds to hire an attorney to help secure non-profit status. Views of the committee were clear on the responsibility of the Odd Fellows to pursue these goals without additional funding from CPC. Julia referred to the May 2012 warrant article.

Fleck Property - Phase II (Catherine Hertz) - No new information.

Sea Call Farm Orchard Rehabilitation (Steve Bornemeier) – No new information.
