by The Nature Conservancy. Proposed testing for possible sites of eelgrass restoration. Work will occur on Land Under the Ocean.

Karen Lombard from the Nature Conservancy said there are a number of sites where test planting of eel grass is proposed on the bay side, Town Cove, and Pleasant Bay. Only 3 square meters will be planted and monitored over the coming year to see if there is success at that site. Some of the sites are in a channel where boat traffic is a concern. There are also shellfishing areas, a nourishment site for Skaket Beach, and possible private property. These sites need to be approved by the Harbor Master. The contractors will be looking at all the sites from May until August. They requested to continue to July 13th after the sites have been reviewed.
