FINANCE COMMITTEE MINUTES

The March 18, 2010, meeting of the Orleans Finance Committee was convened by Acting Committee Chairman Dale Fuller at 7:00 p.m. in the Nauset Room of the Orleans Town Hall. Present constituting a quorum were Mr. Fuller, Edwin Barr, Gwen A. Holden Kelly, and Paul Rooker. Member Rick Sigel arrived following the vote on the minutes of previous meetings.

Approval of Minutes

- Minutes of the March 11, 2010, Meeting: A motion made by Mr. Barr to approve the minutes of the March 11, 2010, Finance Committee failed due to a lack of a majority of Finance Committee members voting (4-0-2).

Discussion with the Town Administrator

Mr. Kelly responded to questions from Finance Committee members concerning the proposed operating and capital expenditures under Town fiscal year 2011 budgets.

The Finance Committee will seek clarification on whether the Community Center might provide a suitable site for the temporary housing of certain Highway Department employees who must be moved in the short-term from the facilities where these employees currently are housed owing to a mold problem.

The Finance Committee plans to revisit this vote at its March 25th meeting. The vote reflects the Committee's desire for additional information concerning the proposed appropriation of \$30,000 to renovate the American Legion Hall to accommodate the relocation of certain Highway Department employees owing to a mold problem in the facilities where these individuals currently are housed. The Finance Committee will seek clarification on whether the proposed expenditures are intended to produce a temporary solution to the need to relocate these employees in the short-term or also are being pursued as an integral component of longer-termed plans to meet office space requirements associated with the creation of a Town Department of Public Works and Natural Resources.
