FINANCE COMMITTEE MINUTES

The March 31, 2011 meeting of the Orleans Finance Committee was convened by Chairman Larry Hayward at 7:00 p.m. in the Nauset Room of the Orleans Town Hall. Present constituting a quorum were Chairman, Mr. Larry Hayward, Vice Chairman, Ms. Gwen Holden Kelly, Secretary, Mr. Mark Carron, Members, Mr. Ed Barr, Mr. John Hodgson, Mr. Paul Rooker and Mr. Dale Fuller. Member Mr. Rick Sigel joined the meeting at 7:40.

Mr. John Nichols of East Orleans spoke on behalf of the petitioners for the Resolution Article.

Article Putnam Property \$78,000

Chairman of the Open Space committee Mr. Alan McClennen presented the need for the Article to Fund the Preservation of Putnam Farm. Round numbers he indicated \$10,000 for repairing the barn, \$4,500 to repair the electricity line, \$25,000 t truck in loam from the Transfer Station, \$25,000 to install a drive way, \$5,000 to remove the greenhouses and some money needed to be allocated to repair the well point to reestablish the well for water. There was a good question and answer period regarding this article, asking if this was part of the management plan, could the program be scaled back and if the use could pass the bonding requirements?

These funds will be used to install a new Oil Tank at the Town Hall Annex. As a result, \$3,500 was removed for the Town Office Building Budget.
