1. Minutes of Sept. 20, 2013

Under 7. 0f the September 20 minutes, Community Preservation

2. Jim Cooley Hearing on: 12 Carriage Place -- partial demolition

Mr. Cooley presented photographs of the existing structure and a sketch with floor plan of the proposed new and old structure done by an architect. There is a Massachusetts Historical Commission form B for this property dating the oldest part of the house to ca.1920. The part that he proposes to tear down is comprised of several later additions with uncertain dates possibly late 19th century or early 20th century. The Commission did a site visit inside and outside both the old and newer in parts of the house. The crawlspace under the ells was viewed by Brian Besse, a contractor and Commissioner. He said that it was impossible to date and that many beams have been replaced. The condition of the ells is not good and not functional. It was moved by Bryant Besse and seconded by Ron Peterson that these ells, the portions to be demolished, are not "preferably-preserved historic structures", therefor a demolition permit may be issued. **Motion Passed Unanimously.**

3. Todd Thayer 20 South Orleans Road demolition permit update
