Meeting called to order by Chair Carolyn Kennedy at 10:00 am.

- 1) Minutes of the December 17 Special Meeting were approved. 4-0-1
- 2) Minutes of the December 20 Regular Meeting were approved 5-0-0
- 3) Task Force Annual Report: Carolyn distributed a final copy of the WQTF Annual Report to be included in the Fown Annual Report.
- 4) Future Meeting and Namskaket Sampling Schedule was distributed. Attached.
- 5) Cedar Pond Project Discussion centered around options for management and next steps.

Option A: Saline state. (~35 ppt salinity)

Necessitates major construction and dredging of input waterway

Maximum sensitivity to nitrogen input

Would not support herring spawning or eel maturation

Water level would fluctuate with the tides

Danger of flooding low lying properties on maximum flood tides

Danger of destroying current White Atlantic Cedar Swamp

Threat of silting in pond and input waterway

Offers an opportunity for aquaculture

Option B: Brackish (</= 12 ppt salinity)

Necessitates construction of a water level control structure

Sensitive to phosphorous and nitrogen inputs

Offers some nitrate attenuation to the Rock Cheek estuary

Supports herring spawning and eel maturation with a herring ladder

Maintains the historic, relative constant water level

Protects the White American Cedar Swamp

Option C: Fresh (< 3 ppt salinity)

Need a somewhat more elaborate water level control structure than B

Maximum sensitivity to phosphorus input

Offers maximum nitrate attenuation to the Rock Cheek estuary

Supports herring spawning and eel maturation with a herring ladder

Gives a slightly higher than historic, constant water level

Higher water level might impact the White American Cedar Swamp

Next Steps: Judy S. to contact DEP and Brian Dudley for their input

Carolyn K. to contact John Kelly, Sarah Peak and Dan Wolf to solicit their support in forcing NSTAR and DOT participation. Carolyn will also research private companies with on-Cape pond remediation experience.

- 6) Namskaket Sampling. Carolyn and Gilbert to sample in January. Ken and Gilbert to sample in February. Gilbert to check Kim VanThaden if Ken is unable to sample in February.
- 7) Cape Cod Commission Sub-committee Meeting: Tuesday January 18. Carolyn to report on Task Force support of CWMP.
- 8) New Business: Charles Harris reported that Eastham is writing a RFP for remediation of their freshwater ponds. He reminded us that there is a hurricane super high tide once or more every 25 years and to consider that in our Cedar Pond plans. Eastham has a professional report on their Town Web site now giving recommendations on freshwater pond remediation.

Beth Carney wanted to know where the Town Cove MEP report was and if Findlay Road and Lots Hollow Roads were part of the Rock Harbor watershed. The task force responded that we too were awaiting the Town Cove report and that Findlay and Lots Hollow Roads were part of the Rock Harbor watershed.
