FY '14 BUDGET RECOMMENDATIONS - ORLEANS COMPREHENSIVE PLAN

LARGE HOME PROPOSED ZONING BYLAW AMENDMENT

Planning Board members reviewed and discussed a potential zoning bylaw under §164-21 with Special Permit criteria through the Zoning Board of Appeals for large homes. Planning Board members also reviewed a zoning bylaw amendment to the definition of buildable upland under §164-4. Planning Board members agreed to make a decision of whether to forward this bylaw to a public hearing at the December 11, 2012 meeting.

Fallender gave a report of a recent ribbon cutting ceremony for the walkway between Main Street and Cove Road, as well as upcoming events of the Orleans Community Partnership.
