Michael Smith explained that this project has been redesigned to comply with zoning in terms of setbacks from sidelines and meets the requirement for additional parking.

## **Comments**:

<b>Building:</b>	There were no Building Department comments.
Water:	There were no Water Department comments.
Health:	The project is located in the Village Center District and is exempt from the
	Nutrient Management Regulations. The current Disposal Works Construction
	Permit expires in April 2014 and due to the scope of work changing with the
	installation of a new septic tank, a new permit will be required. The Site Plan
	does not indicate that the system is H20 rated so confirmation from an engineer
	will be required, or the driveway must be relocated, or a new system must be
	installed. No floor drains are allowed.
<b>Conservation:</b>	Applicant received approval in 2007 and will need approval for the new work.

**MOTION:** On a motion by **Bob Canning**, seconded by **Todd Bunzick**, the Committee voted to accept the Site & Sewage Plan by FELCO, Inc, dated 1/5/2014 as the Formal Site Plan conditional on the evaluation of the septic system.

**VOTE:** 5-0-0 The motion passed unanimously.

# INFORMAL REVIEW: NAPA Auto Parts, 3 Nells Way

David Michniewicz (Coastal Engineering Co.) described changes proposed for the property used by NAPA Auto Parts including existing and proposed parking spaces, an addition for retail storage, traffic patterns around the building, change in curb cuts, enclosed trash area, loading area, pavement replacement, on-site drainage, septic system replacement, and a retaining wall.

#### **Comments:**

**Building:** 25-year storm drainage must be contained on-site and drainage calculations must be prepared by a Professional Engineer and provided to the town and shown on the Formal Site Plan. All exterior lighting must conform to the Orleans Lighting bylaw (shielded and pointed downward) and manufacturer tear sheets must be
