Financial Report:

- Sandra Rhodes presented the November 2011 Monthly Report (copy attached).
 - Depletion Accounts: Salaries included 4 pay weeks. Operating Expenses included payments of \$3.1k for replacement of the fire alarm panel and \$4.4k for books and materials. Site Improvements included \$2,327.50 for the architectural review of the front entrance.
 - Revolving Accounts: State Aid reflected payments for the Wall Street Journal and a deposit of \$18,972.05 from State Aid.

 - A Meeting Room Reservation Request for Authors has been received from Friends of Snow Library for the following authors: Linda Greenlaw, Joshua Blair Delaney, Mahala Busselle Bishop, Geraldine Brooks and Andre Dubus III, to offer presentations of their work and provide their books for sale during the Lifetime Learning Program. A motion was made and seconded "to approve the request by Friends for the sale of the authors' books (listed above) during their presentations for the Lifetime Learning Program". SUMMARY:

- Received correspondence from the Orleans Cultural Council that grant application for collaborative poetry program was not approved for funding. Notification stated, "project does not provide enough public benefit for the Orleans community compared to other proposals". Working with Director to locate alternative funding as I believe this program would be a quality literary-based program with merit for the library and local school aged children.
- Attended Children's Roundtable meeting of Cape youth services librarians and attended a demonstration for the computerized early literacy stations available for purchase which are being used in many public libraries.

Snow Library Youth Services Report JANUARY 2012

SUMMARY: (Continued)

- Continuing to work with Director Reuland to address issues related to large number of middle school students coming into the library after school hours which is requiring almost constant time and attention from staff between the hours of 2:50 p.m. 4:15 p.m. each school day. Approximately 30% of the youth work on homework, but the other 70% are "hanging out". At times youth have had to be asked to leave after wrestling, jumping on furniture, etc. I have spoken with NRMS Assistant Principal Cameron who stated she visited the library last week and wasn't pleased with behavior she witnessed and spoke with the offending students she knew at the time. I inquired about school policy for dismissal plans for students and learned that students are allowed to be dismissed at this age without the school knowing their plans. However, the school offers many free afterschool programs for families which include cooking, drama, art, sports, etc. which families have been reminded of. The school is willing to support our efforts, but once the students leave the school property their ability to intervene is compromised.
- Collection Maintenance:
 - Shifted collection in Picture Books, Early Readers, and Parenting to make room on the shelves.
 Added new signage to Parenting and Easy Reader sections to improve patron access and re-shelving.
 - Weeded Juvenile Board Books
 - Weeded Parenting Collection: Picture Books and Non-Fiction
 - **■** Weeded Juvenile Picture Books
- Community Outreach:
 - Contacted Nauset Regional High School Guidance Department for list of current AP classes offered through the school so we can purchase the corresponding study guides to update our YA collection.
- Display:
 - Created small display in Children's Room cabinet with snowmen and related books. Posted sign encouraging children with collections which they might like to share to sign-up at the Children's Desk for display space for a month.
 - Contacted local schools to see if they would like to utilize the lobby display case to feature student work. Nauset Regional Middle School will create a display in February, and NRHS will display in April.

PATRON BEHAVIOR POLICY OF SNOW LIBRARY

When the behavior of a patron constitutes a disruption which interferes with the use of the library by other patrons or staff members carrying out his/her duties, the following steps will be taken:

- 1. A verbal warning will be issued. If the behavior in question does not cease, the patron will be asked to leave. Use of foul or abusive language will be grounds for immediate removal from the Library. Failure to provide a print form of identification when requested to do so, will be grounds for immediate removal from the Library.
- 2. If the patron refuses to leave, inform him/her that the police will be called.
- 3. Call the police.
- 4. If the offender is an unaccompanied juvenile, the child's parents may be called in lieu of police.
- 5. A patron who repeatedly fails to conform to behavior standards may be denied access to the Library permanently.
- 6. Any time a staff member feels that a patron's behavior threatens the safety of other patrons or staff members, the staff member in charge will call the police immediately.

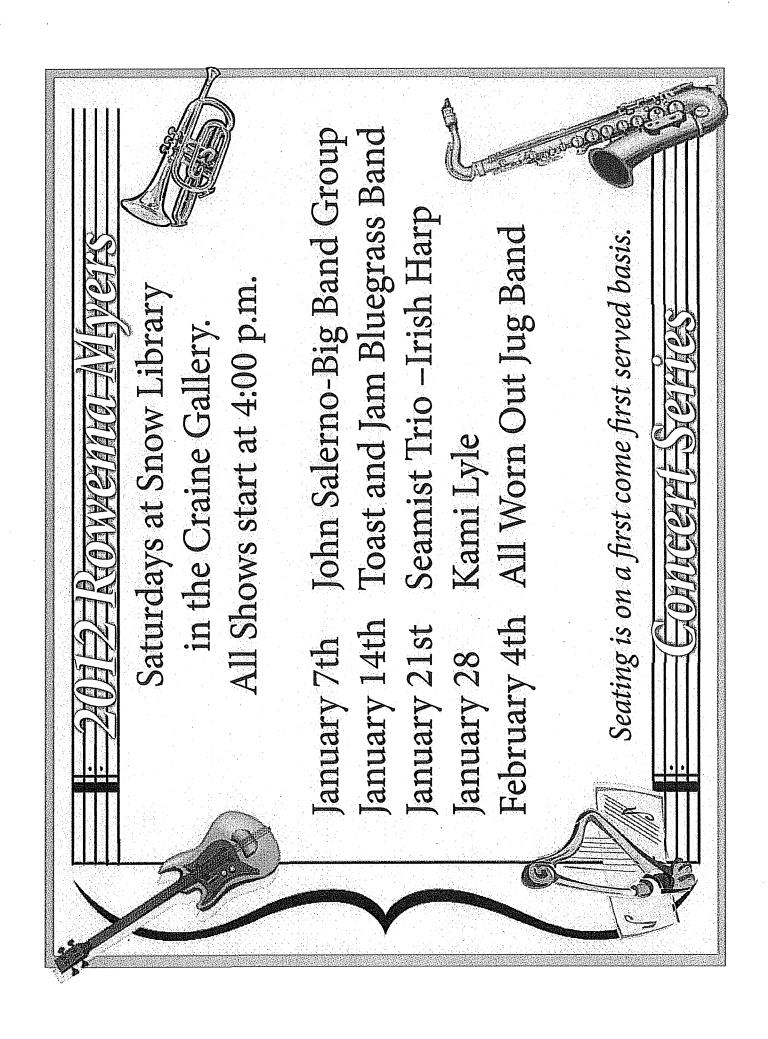

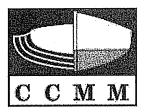

CUMMINGS COLLECTION POLICY

PURPOSE:

The Cummings Collection was given to Snow Library by Elizabeth Brown Lyons, a niece of H. K. Cummings, as a memorial to her uncle. The collection consists of glass plates, of prints in leather albums available for public viewing, and many archival prints seen around the Snow Library. Cummings' original journal has been restored and encased in a new binding.

The collection does not receive funds from the Library's town budget. An initial grant was obtained to print a complete set of images from all the glass plates; beyond this, the collection is self-sustaining. The preservation of such a collection is on-going and expensive, requiring a safe storage area under archive conditions, and careful supervision. The sale of the H. K. Cummings books and prints help defray the cost of maintaining the collection.

This is a museum-quality collection that provides a history of the community we live in, and is therefore a source of great pride to Snow Library and the Town of Orleans. It is our responsibility to sustain it for future generations.

RULES OF USE:

- The H. K. Cummings Collection is the property of Snow Library. Volumes of photos must remain in the Library at all times. The public is welcome to view the collection following the "Rules of Use" established by the Library Director.
- Prints may be ordered through the Library. Order forms are available upon request from the Reference Librarian, and will contain the current prices for reproduction. Prints may be made for private use, non-profit use, or commercial use. All funds will be used by Snow Library Cummings Restoration Project.

Reproduction for non-profit use:

Prints are made available for use by non-profit organizations at a reduced rate, but prints must be credited as follows: "Reprinted with permission of Snow Library, Orleans, Massachusetts." Also, one copy of the publication item must be presented to Snow Library for its files.

Reproduction for commercial use:

Prints are available for commercial reproduction at the rate of \$50 per print for Snow Library Cummings Restoration Fund (tax-deductible), plus printing costs, and a copy of the published book. The \$50 entitles the donor to one-time use in North America. (Subsequent book editions, beyond the first, must be negotiated.) The acknowledgment line should read "Reprinted with permission of Snow Library, Orleans, Massachusetts." [NOTE: Local newspapers are exempt from the donation, but must pay printing costs and photos must be credited as stated above.]

- Prints owned by the Library may be borrowed at no charge by schools, non-profit or civic groups with permission from the Library Director. Library sponsored exhibits will take precedence in use of prints. Prints must be signed out utilizing the Print Borrowing List located at the Reference Desk, and a listing of name, organization, address and telephone number of borrowers will be kept on file.
- No copying of photos is permitted.

POLICY ON ART COLLECTION AND VALUABLE HOLDINGS

POLICY:

- 1. Acceptance of Art Gifts is at the discretion of the Trustees.
- 2. Loan of Art Work(s) other than the Cummings Collection is with the sole permission of the Snow Library Board of Trustees.
- 3. The care of the Cummings Collection is to be reviewed and updated periodically as photographic storage technology improves.
- 4. An inventory of all Art Objects is to be conducted biannually by the Library Director or the Library Director's appointee.
- 5. All pieces of value are to be appraised every five (5) years.
- 6. Cleaning and restoration will be at the discretion of the Board of Trustees as recommended by the appraiser(s).
