BUDGET WORKSHOP

"A primer for all" presented by Dan Hooper

D. Hooper set up slide show pertaining to Budget Workshop and discussed: Budget Training which was broken down into 3 parts: Basic (May), By DRA (June) Timely (Sept); Basic Training and it's goal; Outline of Basic Training Topics: Understanding the RSAs which are the State laws under which we operate; revised statues annotated; which ones are commonly used (Chapter 32 & 40); SB2 and its impact (Senate Bill 2); and Purpose of the Budget Committee.

Board discussed purpose of the Budget Committee. Noted was the Budget Committee is the Appropriations Committee.

K. Lewis Savage discussed Budget Committee members getting information from department heads however the BOS has say over the department heads. Noted was that Department Heads are wanted to be in attendance for the initial presentation of the budget to answer questions.

D. Hooper noted that a quorum for the Budget Committee is seven or more. Absenteeism of 4 or more unexcused absences removes you from the committee.

Board reviewed and discussed Expenditures and Revenues worksheets which were emailed to all members earlier.

Board discussed next meeting which will be announced at a later date.
