## Public Comment -

Sue Hickey, owner of M\&M Sporting Goods, and Kim McDonough, owner of joyfly’s Buzz PR | Marketing, put forth a request for Special Uses of parking spaces and at least $\$ 3,500.00$ in funding to help promote and produce events and activities taking place during "Hollywood East on Main Street", a four day event happening downtown Plymouth on July 10-13, 2008. The promotion is in partnership with Plymouth Rock Studios, Plymouth Area Chamber of Commerce, Destination Plymouth, area merchants, waterfront concert producers and has Mr. Sylvia's support.

Mrs. Hickey presents a projected expense report and explains how the established advertising partnership agreements work. Ms. McDonough requests permission to block parking spaces at the Courthouse Green area on Saturday July 12 from 3-9:30 p.m., for the production taking place in that location. Blocked spaces include the two parking spaces in front of the Courthouse lawn and the three, two hour timed spaces located at the Synagogue and the areas surrounding the Courthouse lawn. Russell Street lots would be for "Event Parking Only". Ms. McDonough has spoken to Captain Botieri about street closings and he is willing to work with her on the street closings and police detail plans as things develop. Mrs. Hickey placed a preliminary call to the County Commissioners about gaining their support for use of the Green and will meet with them next week to gain their permission.

Ms. Pratt asks how much money is being sought from the Board and if there was any expectation that merchants would contribute to the finances. Mrs. Hickey states she is seeking the whole $\$ 3500.00$, if not more from the Board, and merchants will be asked to pay a $\$ 50.00$ participation fee, which will go toward covering any leftover expenses and staffing for the Courthouse Green event on July 12. Ms. McDonough states she would prefer $\$ 5,000.00$ be invoiced directly to PGDC, it is a more accurate expense number, and she will be responsible for providing PGDC with any 1099's for entertainers. Plymouth Growth \& Development Corporation will also be named on the event insurance policy that joyfly's Buzz PR | Marketing is required to purchase for the event on July 12.

Mr. Zanotti asks Mrs. Hickey and Ms. McDonough to come back before the Board and report on the success of the event and how monies were collected and spent. He supports this type of reinvestment of Park Plymouth funds; it is what the downtown community needs, but wants to remind the Board of their obligation in the contract with the Town to increase parking.

Mr. Hallisey motions to allocate up to $\$ 5000.00$ for the event, to be invoiced directly to Plymouth Growth \& Development Corporation, to provide the requested blocked spaces, with Plymouth Growth \& Development Corporation named as a primary insured on the liability policy. Mr. Bletzer seconds.
