## **CALL TO ORDER**

Chairman Hallisey called the meeting to order at 6:08 p.m. and led the Pledge of Allegiance.

## PUBLIC HEARING: ANNUAL ALL ALCOHOL RESTAURANT LICENSE BKMRN, INC. D/B/A LEON'S PLACE, 47 COURT STREET

Chairman Hallisey opened a public hearing to consider the application for a new Annual All Alcohol Restaurant Liquor License from BKMRN, Inc. d/b/a Leon's Place, 47 Court Street, Carrie DeMeule as Manager. Chairman Hallisey affirmed that notice of the hearing was given in accordance with Chapter 138 of the Massachusetts General Laws and those wishing to speak on the matter were encouraged to attend.

Leon Marinos and Brenda Marinos of BKMRN, Inc. appeared before the Board on behalf of the license application.

The Board posed no questions regarding the license. Chairman Hallisey opened the hearing to public comment. No citizens came forth. Chairman Hallisey then closed the hearing and awaited a motion of the Board.

On a motion by Vice Chairman Mahoney, seconded by Selectman Harnais, the Board voted to approve a new Annual All Alcohol Restaurant Liquor License (as presented in the license application) for BKMRN, Inc. d/b/a Leon's Place, 47 Court Street. Voted 3-0-0, approved.

# PUBLIC HEARING: ANNUAL WINE & MALT WITH LIQUEURS & CORDIALS GENERAL ON-PREMISE LICENSE

L & L WINE CELLAR, INC. D/B/A THE WINE CELLAR, 690 STATE ROAD

Chairman Hallisey opened a public hearing to consider the application for a new Annual Wine & Malt with Liqueurs & Cordials General On-Premise License from L & L Wine Cellar, Inc. d/b/a The Wine Cellar, 690 State Road, Loring Tripp III as Manager. Chairman Hallisey affirmed that notice of the hearing was given in accordance with Chapter 138 of the Massachusetts General Laws and those wishing to speak on the matter were encouraged to attend.

Loring Tripp III of L & L Wine Cellar, Inc. explained his intention to convert the lower level of 690 State Road—the same building that houses Foppiano's Restaurant—into a wine bar. Mr. Tripp talked about plans to host educational workshops at the bar where patrons can learn about wine and cuisine from trained chefs and sommeliers.

Vice Chairman Mahoney noted that Mr. Tripp's home address was listed in the notice for the license hearing. Mr. Tripp clarified that his home address is that of the corporation (L & L Wine Cellar, Inc.); the actual wine bar establishment will be located at 690 State Road.

Seeing no further questions from the Board, Chairman Hallisey opened the hearing to public comment.

Sam Chapin asked the Board to confirm that no sale of alcohol will take place from the residential address that was listed in the hearing notice (West Long Pond Road). Chairman Hallisey explained that the Board read the business address (690 State Road) into the record for the license application. No license-related activity will take place at the corporation's residential address, Chairman Hallisey said.

There was no further comment from the public, and, thus, Chairman Hallisey closed the hearing to await a motion of the Board.

On a motion by Vice Chairman Mahoney, seconded by Selectman Harnais, the Board voted to approve a new Annual Wine & Malt with Liqueurs & Cordials General On-Premise License (as presented in the license application) for L & L Wine Cellar, Inc. d/b/a The Wine Cellar, 690 State Road. Voted 3-0-0, approved.

Mr. Carvelli stated that he has maintained operations at the restaurant since the purchase, but without the service of alcohol (while waiting for the transfer of the license). The business will remain the same as it was under the previous owners—open seven days per week with the service of beer and wine, only—but with more direct supervision under his ownership.

Chairman Hallisey opened the hearing to public comment. No citizens came forth to speak, and, thus, Chairman Hallisey closed the hearing to await a motion of the Board.

On a motion by Selectman Harnais, seconded by Vice Chairman Mahoney, the Board voted to approve the Transfer of an Annual Wine & Malt Restaurant Liquor License <u>from</u> Moose Pond, Inc. d/b/a Upper Crust Pizzeria, 15 Court Street <u>to</u> ABCC, Inc. d/b/a The Upper Crust Pizzeria Plymouth, 15 Court Street. Voted 3-0-0, approved.
