CALL TO ORDER

Vice Chairman Mahoney called the meeting to order at 5:30 p.m.

LICENSES

ONE DAY WINE AND MALT LIQUOR LICENSE*

- ❖ **John Salvucci / The Pie Hole** requested two (2) One Day Wine & Malt licenses for a weekend grand opening celebration to be held at The Pie Hole, 20 Court Street, from 11:00 a.m. to 12:00 a.m. on August 24 and 25, 2012. Liquor Liability is in place.

*One day liquor licenses shall automatically cover the day before and the day after the event for the purpose of proper delivery, storage and disposal of alcoholic beverages purchased.

Steve Delisle addressed the Board on behalf of his business partner, John Salvucci, and The Pie Hole. In response to a question from Selectman Tavares, Mr. Delisle reported that he and Mr. Salvucci have not yet decided whether they will apply for an annual liquor license, as they would prefer that their establishment be known primarily for its food. Mr. Delisle indicated that he and Mr. Salvucci may consider requesting another one-day license for future special events at the restaurant.

Selectman Tavares encouraged Mr. Delisle to consider filing for an annual liquor license, rather than continuing to file for one-day licenses on a periodic basis. Businesses that hold annual liquor licenses, he said, are subject to a number of rules and regulations to which one-day licensees are not bound. As such, Selectman Tavares stated that he would not support any future requests for one-day licenses from The Pie Hole, as, in his opinion, it would be unfair to grant one-day licenses to any restaurant establishment on a regular basis, while others follow the more regulated process of annual licensing.

On a motion by Selectman Brewster, seconded by Selectman Harnais, the Board voted to grant two (2) One Day Wine & Malt licenses to John Salvucci / The Pie Hole, for a weekend grand opening celebration to be held at The Pie Hole, 20 Court Street, from 11:00 a.m. to 12:00 a.m. on August 24 and 25, 2012. Voted 4-0-0, approved.

Tiffany Park, the Selectmen's Assistant, provided Mr. Delisle with the rules pertaining to last call and the hour by which all alcohol must be removed from the premises.

ADJOURNMENT OF MEETING

On a motion by Selectman Brewster, seconded by Selectman Harnais, the Board voted to adjourn its meeting at approximately 5:40 p.m. Voted 4-0-0, approved.
