## **ENTERGY: PRESENTATION ON SAFETY AND EVENTS AT FUKUSHIMA** JOINT MEETING WITH NUCLEAR MATTERS COMMITTEE AND LEGISLATORS

Chairman Muratore thanked all of the legislators, legislative assistants, Entergy representatives, and members of the Nuclear Matters Committee for their participation in the meeting.

Rich Rothstein, vice chairman of Plymouth's Nuclear Matters Committee ("NMC"), called a meeting of the committee to order at approximately 7:15 p.m.

Joseph Lynch, Entergy's Regulatory Assurance Manager at Pilgrim Nuclear Power Station ("PNPS"), began a PowerPoint presentation on safety measures at the station and the events that took place at the Fukushima Dai-Ichi Nuclear Power Station. Prior to commencing the presentation, Mr. Lynch offered information on his professional background and the role in which he serves at Pilgrim. PNPS, he informed the Board, began commercial operation in 1972 under the ownership of Boston Edison. In 1999, PNPS was acquired by Entergy, which renewed the facility's license with the federal government in 2012 for another 20 years (until 2032). Since that time, Mr. Lynch indicated, Entergy has invested \$500 million to modernize the high-security facility. PNPS employs 650 individuals, pays the Town of Plymouth approximately \$10 million annually through a Payment-In-Lieu-Of-Tax ("PILOT") agreement, generates enough carbon-free electricity to power approximately 680,000 homes, and produces a \$145 million annual regional economic impact.

Mr. Lynch provided the Board with a detailed description of the way by which Pilgrim's boiling reactor is designed, contained, and operated. He provided a comparison between the design of the reactor at PNPS and that of the six reactors at Fukushima. Mr. Lynch then focused on the catastrophic events that occurred at Fukushima, immediately following the earthquake and tsunami events of March 2011 in Japan. He explained the sequence of events that led to the failure of the plant's back-up systems, which eventually resulted in the rupture of the containment systems surrounding three of Fukushima's reactors. Despite the significant damage to the reactors, Mr. Lynch noted, the spent fuel pools at Fukushima sustained no damage.

Mr. Lynch talked about the procedures and secondary systems in place at PNPS that would prevent such failures from happening in Plymouth, in the event of a significant power loss or disruptive event. Plymouth, he said, is geologically different from Fukushima, Japan, in that it has little history—and a low probability—of seismic activity and/or susceptibility to tsunamis. Mr. Lynch noted that PNPS operates a single reactor unit—as compared to Fukushima's six reactors—and, therefore, the attention of the staff at Pilgrim is focused entirely upon one single reactor. Since the events at Fukushima, he reported, Entergy has supplemented its back-up systems with additional diesel-powered generators, placed at a higher elevation within the site. It should be noted, Mr. Lynch said, that Pilgrim's operators go through a more rigorous and frequent training schedule than the staff at Fukushima. With regard to security, he indicated, PNPS has improved its security force since the events of September 11, 2001.

Following the disaster at Fukushima, Mr. Lynch explained, the United States Nuclear Regulatory Commission ("NRC") has analyzed the sequence of events that occurred and the procedures and back-up systems that may have led to the failure of the reactors. As a result, the NRC has issued three orders to U.S. nuclear facilities pertaining to mitigation strategies (beyond design-basis events), containment vents, and the instrumentation used in spent fuel storage pools.

Phil Harizi, Senior Lead Mechanical Engineer at PNPS, resumed the presentation with further information on the events that occurred at the Fukushima Dai-Ichi Nuclear Power Station. Mr. Harizi, who has 25 years of experience in the electro-power industry, explained that he is responsible for addressing any adverse or unplanned incidents that could occur during the operation of PNPS. Following the NRC's issuance of the post-Fukushima orders, Mr. Harizi noted that he was assigned as the Engineer Lead for the "Post-Fukushima FLEX Strategy."

Mr. Harizi talked further about the NRC's FLEX Order, which mandates that all U.S. nuclear facilities—regardless of location and seismic environment—must devise a "FLEX" strategy of how to shut down the nuclear reactor, in an event similar to what happened at Fukushima. In the case of typical events at the facility, he explained, staff can cool and shut down the reactor safely, address the issue, and restart operations. In the scenario that the NRC has asked us to play out, he indicated, PNPS must demonstrate that its staff can shut the reactor down and address any decay heat by keeping the core submerged in water at all times.

Mr. Harizi informed the Board that, so long as reactor operators can provide two gallons of water per minute to the core cooling area, the core can be maintained at a manageable temperature during a shutdown incident. The FLEX mitigation strategy, he explained, relies on the ability of completely independent equipment to deliver the water necessary to maintain temperatures within the reactor during a major power failure. The NRC requires that this independent equipment be protected and stored in two locations. Mr. Harizi stated that the fatal flaw at the Fukushima facility was that this strategy was not in place. For example, he said, if a tsunami were to strike the coast of Plymouth and eliminate power to the facility, staff at PNPS would be able to make use of its independently-stored auxiliary equipment to safely shut down the plant and maintain cooling in the reactor. So long as there is a constant supply of water to the reactor, he assured the Board, the core will not melt.

Mr. Harizi provided further details on the various back-up systems in place at PNPS that will ensure the delivery and circulation of water around the reactor core, in the event of a complete power failure. The NRC's FLEX mitigation strategy also requires the maintenance of regional response centers that can deliver equipment or supplies (such as fuel) by helicopter within 24 hours of an event, if necessary. Mr. Harizi explained that, if something catastrophic were to happen at PNPS, to the point that the facility sustained such damage that it would no longer be operable, staff would simply focus on keeping the reactor core cool.

Mr. Harizi closed his presentation with the following assertions:

- Pilgrim Nuclear Power Station is not Fukushima
- PNPS has significantly better safety and reliability mechanisms
- PNPS conducts continuous safety evaluations and improvements

Mr. Harizi and Mr. Lynch fielded questions from the Selectmen, legislators and legislative assistants, and members of the Nuclear Matters Committee ("NMC"). In response to questions from Vice Chairman Brewster, Mr. Harizi provided further details on the secondary systems in place at PNPS, noting that the facility retains an on-site fuel supply that can operate the array of independent fuel pumps for approximately 30 days. In the unlikely event that the local power grid is offline for more than 30 days, both Mr. Harizi and Mr. Lynch indicated that PNPS would seek delivery from local fuel suppliers, and/or the aforementioned regional response centers.

Senate President Therese Murray and NMC member Rich Rothstein Entergy's representatives to discuss the reliability of power service to PNPS. Mr. Lynch reported that, following the blizzard event of February 2013, Entergy has been encouraging NSTAR to upgrade the poles on its main supply line from wood to steel. NSTAR has indicated that it cannot conduct such upgrades until January, Mr. Lynch noted. Senate President Murray expressed concern that NSTAR would delay such upgrades, considering the intrinsic importance of providing power to a nuclear generation facility.

Chairman Muratore inquired if the Entergy representatives had brought with them the requested follow-up responses to some of the questions they could not answer during the

October 8, 2013 Selectmen's meeting. Joyce McMahon, External Affairs Representative for PNPS, noted that the responses would be submitted to the Board, in writing.

Mike Jackman of Congressman Keating's office asked Entergy's representatives to indicate how it will handle long-term power outages, while the NRC's (aforementioned) FLEX-required, off-site regional response centers are not yet operational. Mr. Harizi acknowledged that the regional response centers are currently incomplete, but he noted that the facilities must be operational within 5 years of the NRC's post-Fukushima orders. Mr. Harizi noted, however, that PNPS has prepared its secondary systems to address power outages without ever having to rely on these response centers.

Chairman Muratore opened the presentation to questions from the audience.

Mary Lampert from Duxbury posed a number of technical questions to Mr. Harizi regarding the NRC's recommendations pertaining to dry-well vents and temperature monitoring controls in the spent fuel pool. Mr. Harizi provided information in response to Ms. Lampert's questions, noting that Entergy recognizes the value of having temperature indicators within the spent fuel pool.

Cynthia Spratt of North Plymouth expressed concerns about the lack of protections for residents, during the span of time between the issuance of the NRC's safety orders and the actual installation and/or implementation of the required system upgrades. Mr. Lynch explained that, as long as the temperature in the reactor core and spent fuel pools are maintained, there is no threat of radioactive release.

Ana Baker commented that Entergy's presentation focused on the differences between PNPS and Fukushima, while information on the similarities between the two facilities was omitted. Ms. Baker referenced the unavailability of fuel in the New Jersey/New York area after Hurricane Sandy, and, thus, she questioned how a similar event could affect the ability of PNPS to maintain its fuel supply. Mr. Lynch reiterated that Entergy maintains a fuel supply that will last for 7 days, if all of the emergency generators are operating at full capacity (i.e. a worst-case scenario. With regard to comparisons between PNPS and Fukushima, Mr. Lynch explained, the design of the reactors utilized at both facilities is the same, but there are stark differences in how the reactors are operated.

Bill Maher of Falmouth acknowledged the information provided by Entergy with regard to protections against natural disasters, yet there has been little information provided about protections from terrorist attacks—an issue that is most concerning to him. Mr. Lynch informed Mr. Maher that Entergy has undertaken significant security measures to mitigate such threats, following the attacks of September 11, 2001.

Pine Dubois from Kingston asked Mr. Lynch and Mr. Harizi to discuss how PNPS responded to the challenges posed by the Blizzard of February 2013. Ms. Dubois also asked Entergy's representatives to indicate the elevation at which PNPS's back-up pumps are stored. Mr. Lynch acknowledged that PNPS shut down during the blizzard due to a loss of power, but all of the generators at the facility operated as planned. With regard to

the elevation of PNPS's pumps, Mr. Lynch could not offer specific information, but he reported that the entire facility, itself, is situated 10 feet above the highest recorded storm surge.

David Agnew from Harwich inquired about Entergy's policies on the venting of its reactor, in the event that the pressure within the reactor reaches a certain level. Mr. Harizi explained the circumstances under which the reactor at PNPS would be vented, in an instance where pressure reached a level beyond safe operation. Mr. Harizi also provided a detailed account of the sequence of events that resulted in the explosive ignition of hydrogen at Fukushima.

Mary Lampert of Duxbury returned to the podium to ask Entergy's representatives to comment on the company's plans for the spent fuel pool at PNPS, following the closure of the facility. Mr. Lynch indicated that he was not prepared to speak about Entergy's plans for fuel storage, noting that he would have to seek this information from company officials.

Mr. Jackman of Congressman Keating's office inquired if the NRC has required Entergy to conduct climate modeling for sea-level rise, given the NRC's extension of PNPS's license to 2032. Mr. Lynch indicated that, as part of the lessons learned from the Fukushima incident, PNPS was required to look at flooding levels and compare the facility's initial design to the location's current conditions.

Following some brief remaining discussion regarding the security measures that are in place at PNPS, Chairman Muratore thanked Entergy's representatives for their presentation. He reminded the representatives to provide the Board with a follow-up response to any questions that could not be answered during their October 8<sup>th</sup> and December 3<sup>rd</sup> presentations.

Chairman Muratore introduced a discussion with Plymouth's state and federal legislators (and/or their legislative representatives) on the storage of spent fuel at Pilgrim Nuclear

Power Station ("PNPS"). The Board of Selectmen, he said, seeks assistance from its legislators in ensuring that the federal government fulfills its obligation to safely store the nation's spent nuclear waste.

Senate President Therese Murray asserted that, as Plymouth's representative in the Massachusetts Senate, she has been pressing federal legislators and the NRC for many years to release funds collected through the Nuclear Waste Fund for the safe storage of spent nuclear fuel at PNPS. The Senate President affirmed her concerns about the unanswered question of how long the fuel generated by Pilgrim will remain in Plymouth. While it is good that Entergy appears to be following the NRC's post-Fukushima orders, she said, it is just important that the federal government work on the issue of how the billions collected through the Nuclear Waste Fund will be spent. The prospect of the federal repository at Yucca Mountain, she said, does not appear to be likely, at this time. Senate President Murray commended Selectmen Brewster for her efforts to form the Coalition of Nuclear Communities, she said, but Massachusetts' federal delegation must also join together to ensure that the government fulfills its promise to take responsibility for the storage of spent nuclear fuel.

Mike Jackman, District Director for Congressman William Keating, expressed the Congressman's regrets for not being able to attend the meeting, due to his congressional session schedule. The issue of spent nuclear waste is very political, Mr. Jackman said, especially with regard to the planned—and halted—proposal to site a federal repository at Yucca Mountain in Nevada. Mr. Jackman assured the Board that the issue of nuclear waste storage at PNPS is very important to Congressman Keating.

Christina Pacheco from U.S. Senator Ed Markey's office expressed her disappointment that Entergy's expert on dry-cask storage was not present for the discussion, as the Senator's questions were primarily geared towards that particular topic. The Senate President, Ms. Pacheco stated, was most likely correct in her assertion that the Yucca Mountain repository does not appear to be a realistic prospect. Senator Markey, Ms. Pacheco indicated, believes that another suitable location for a federal repository must be identified as soon as possible, to alleviate crowding in the spent fuel pools of the nation's reactors. Ms. Pacheco reported that there is a bill currently within committee review in the U.S. Senate that will build upon the findings of President Obama's Blue Ribbon Commission on America's Nuclear Future. Senator Markey, she stated, has asked the Town to reach out to his office on this issue, whenever needed.

Chairman Muratore asked the representatives of Massachusetts' federal legislators to discuss the ways by which their respective elected official might assist with this matter, at the federal level. He asked if there was a way that U.S. legislators could redirect the money from the Nuclear Waste Fund back to the local communities that host the waste.

Stephanie Houghton of U.S. Senator Elizabeth Warren's office noted that the Senator is closely monitoring a bill involving the Nuclear Waste Fund.

State Representative Vinny deMacedo noted that, despite the millions of dollars spent on research and planning, the Yucca Mountain project has been abandoned. Representative

deMacedo expressed his belief that it is now the responsibility of the Presidential administration that abandoned the Yucca Mountain project to ensure that the nation's nuclear power stations—now defacto 'repositories'—are compensated for the safe and sufficient storage of their respective fuel assemblies. Plymouth's federal legislators, he said, must compel the federal government to fulfill its responsibility to provide a new solution, if it has discarded the previous one.

Ms. Houghton from Senator Warren's office noted that Senators Markey and Warren recently issued a joint letter to the NRC regarding the need for improved transparency (on the part of the NRC) regarding the storage of spent fuel.

State Representative Tom Calter emphasized the need for federal legislators to insist upon the development of a renewed federal policy on the storage of spent nuclear fuel. Senator Markey, he said, has been a strong advocate for environmental issues during his 20 years as a federal legislator, and, thus, the Senator has a great deal of experience to take the lead on this issue. While he hates the idea of the fuel remaining here in Plymouth, Representative Calter acknowledged that residents must consider the reality that it will remain here for some time or, perhaps, permanently. In the event that a repository location could actually be identified and constructed, he speculated, the actual transportation of radioactive fuel may be the most difficult obstacle to the removal of fuel from PNPS.

Each member of the Board took an opportunity to thank Plymouth's state and federal delegation for their participation in Entergy's presentation and the discussion on the storage of spent nuclear fuel.

Selectman Provenzano commented on the federal government's failure to fulfill its duty under the Nuclear Waste Policy Act of 1982, which recently prompted the U.S. Court of Appeals to issue a Writ of Mandamus—a rare judicial act—stating that the Executive Branch of government has no authority to disregard congressional mandates based on policy disagreements with the law in question. Though it would certainly be helpful for the federal government to release money from the Nuclear Waste Fund to aid in the transition of spent fuel into dry cask storage, Selectman Provenzano stated, it would be much more preferable for the government to simply make good on its promise to remove the fuel from Plymouth, altogether.

Selectman Tavares recognized Plymouth's state legislators for their long-standing efforts to assist Plymouth with PNPS-related issues, and he encouraged Ms. Pacheco, Ms. Houghton, and Mr. Jackman to relay the importance of this matter to their respective legislators. Plymouth has tried several times to rally other nuclear host communities together (to collectively advocate for policy change at the federal level), but, for various reasons, other communities will not sign-on. Selectman Tavares explained that, when the PNPS project was proposed to Plymouth in the 1960's, the fuel was not supposed to remain at the facility, long-term. Plymouth needs the help of its federal delegation in order to get the fuel moved, or, at the least, stored safely in dry-cask units.

Selectman Mahoney offered his observation that the storage of spent nuclear fuel at PNPS is the signature issue affecting the greater Plymouth area and, perhaps, Cape Cod and the

South Shore. He noted that, as a public official, he does not simply want federal legislators to advocate for Plymouth on this matter, but for all nuclear host communities who are burdened with the issue of spent nuclear waste.

Vice Chairman Brewster cautioned those concerned about the issue of nuclear waste against relying upon a favorable outcome from the Blue Ribbon Commission's legislation, which, in her opinion, will simply create another governmental agency tasked with finding a new location for a federal repository. The deadline for this new agency to complete its mission is 2048, she noted, which means that Plymouth's nuclear waste—dating back to the 1960's—will remain here for almost another 40 years. Vice Chairman Brewster stated her belief that the government should fund (from the Nuclear Waste Fund) the transition of PNPS's spent nuclear fuel into mobile dry-cask units, so that they will be ready for transport as soon as a centralized federal repository is complete.

Chairman Muratore asked that Plymouth's federal legislators make a commitment to pursue the issue of the storage of spent nuclear waste at the federal level. He affirmed that he would be willing to travel to Washington, D.C. to meet with congressional leaders to provide advocacy on the matter, if necessary.

Ms. Houghton, Ms. Pacheco, and Mr. Jackman committed to providing a follow-up response to the Board within 60 days.

Chairman Muratore thanked the legislators and legislative assistants for their participation in the meeting. He called for a brief recess, prior to the next item on the evening's agenda.

## PUBLIC COMMENT

Meg Sheehan of EcoLaw expressed her appreciation for the participation of Plymouth's legislators in the discussion on spent nuclear fuel. She expressed apprehension, however, as to whether the federal government will take any responsibility for the storage of nuclear waste, any time soon. To that end, Ms. Sheehan encouraged the Board to take action on a local level with regard to the storage of spent nuclear waste at PNPS, namely through the imposition of a fee on each storage assembly. In addition, Ms. Sheehan noted her concern that Entergy has not taken into account the trends in climate change and sea level, with regard to the elevation at which it plans to construct the Interim Spent Fuel Storage Installation ("ISFSI") at PNPS.

Mary Lampert of Duxbury echoed Ms. Sheehan's recommendation that the Town charge Entergy for the storage of spent nuclear fuel at PNPS, as an incentive to get the fuel moved to a federal repository. She encouraged the Selectmen to pursue both legislative and civil action through Plymouth's state legislators and the Massachusetts Attorney General's Office, as, in her opinion, state legislators are much more responsive to local issues. Ms. Lampert advised the Board to consider suing the federal government, directly, for compensation through the Nuclear Waste Fund. David Agnew of Harwich expressed concern about the storage of nuclear waste at PNPS, noting that the waste continues to be generated, day after day.

Heather Lightner of Plymouth offered her observation that Entergy plans to remove only the minimum number of older fuel assemblies (into dry-cask storage) necessary to make space in its cooling pool for new assemblies, until the facility ceases operation.

Pine Dubois of Kingston posed the question of 'who' will own PNPS's nuclear waste, once Entergy ceases operations at the facility.

Jean Patenaude Lane advised the Board to band together with all of the communities that fall within a 50-mile radius of PNPS—from Cape Cod to Boston—to advocate for the closure of PNPS. Ms. Lane stated that, as a resident living within a mere few miles of PNPS, she does not feel safe.

Rich Rothstein of the Nuclear Matters Committee offered his recommendation that Entergy should utilize decommissioning funds to pay for the immediate storage of spent fuel (in dry casks). Subsequently, he said, the company can sue the federal government to reimburse these costs from the Nuclear Waste Fund.

### PUBLIC HEARING: TAKING OF NECESSARY EASEMENT BY EMINENT DOMAIN Portion of 32 Nelson Street

Chairman Muratore continued a public hearing to consider the taking of an easement, by eminent domain, over property at 32 Nelson Street, for the purpose of constructing a sidewalk.

Ms. Arrighi indicated that the Board had voted to continue the public hearing on this matter from its previous meeting of November 19, 2013, to allow time for more information to be gathered on accident data at the intersection of Water and Nelson streets. There have been five accidents at that particular intersection within the past few years, she reported, and, thus, the Department of Public Works ("DPW") has recommended that some sort of barrier be established along the proposed sidewalk. Ms. Arrighi noted that she spoke with the chairman of the Town's Parking & Traffic Task Force, who agreed with the DPW that the northern side of Nelson Street would be the most ideal side on which to extend the public sidewalk.

Dan Willis of 32 Nelson Street spoke in opposition of the DPW's recommendation that the Town take a portion of his family's property for the construction of a sidewalk. Mr. Willis indicated that he met with Jonathan Beder (the Director of Public Works) in late November, to discuss the safety of the intersection and the Town's plans to install the sidewalk. During that meeting, he said, both discussed the importance of safety, and it was agreed that both groups could work together towards some sort of arrangement.

Mr. Willis stated that his family would be happy to donate the necessary easement to the Town, if they could be convinced that the Town's plan is safe. Mr. Willis cited a near-accident that occurred at the intersection (in front of his home) during the previous weekend, however, that has convinced him and his family that the Town's plan to continue the sidewalk along the northern edge of Nelson Street is not a good idea. He encouraged the Selectmen and Town staff members to meet with him and stand in the location of the proposed sidewalk, to observe the intersection, first-hand.

Mr. Willis made mention of his family's assertion that it should be allowed permanent vehicular access from a gate at the rear section of 32 Nelson Street through Nelson Park, to the public boat launch. During the Selectmen's meeting of November 19, 2013, he said, the Board appeared to consider his family's claim as a separate issue from the Town's request for the sidewalk easement. Mr. Willis stated his family's belief that the issues are not separate, but, rather, interrelated; the Town has blocked vehicular access from his family's property through Nelson Park, he claimed, as a form of retaliation against his family's unwillingness to agree to the sidewalk easement.

Chairman Muratore opened the hearing to public comment.

Clare Montanari, owner of 29 Nelson Street, sought to address Mr. Willis's recommendation (made during the Selectmen's November 19, 2013 meeting) that the Town opt to construct the sidewalk on the southern side of Nelson Street, which abuts her property. Ms. Montanari stated that her family has owned 29 Nelson Street for 69 years. When many of the older houses were built on Nelson Street, she said, it was a much narrower lane, and, thus, there is not enough room on her side of the street to situate a sidewalk. Ms. Montanari indicated that the Town has already taken 14% of her family's land to make previous enlargements to the intersection of Water and Nelson streets.

The owners of 32 Nelson Street, Ms. Montanari explained, were granted a special permit by the Zoning Board of Appeals ("ZBA") to subdivide their parcel, with the condition that they grant an easement to the Town for the continuance of the sidewalk on the northern side of Nelson Street. Last December, she reported, Mr. Willis's family returned before the ZBA to ask that this condition be deleted, but the request was denied. Ms. Montanari stated her belief that the northern side of the street—the side on which she has observed the majority of pedestrians walking to and from the entrance of Nelson Memorial Park—is the natural place to extend the sidewalk. The intersection is not safe, she said, regardless of where the sidewalk is placed, and, therefore, the Town should consider the institution of one-way traffic or a three-way stop at the intersection.

Everett Malaguti, Town Meeting Member from Precinct 1, agreed with Ms. Montanari that the northern side of Nelson Street is the natural side on which to extend the public sidewalk. The majority of pedestrians use the northern side of Nelson Street to and from Nelson Park and Water Street, he said. Mr. Malaguti acknowledged the traffic problems associated with the sharp turn at Nelson and Water streets and, thus, he recommended that the Town install additional signage and/or speed humps, in addition to the sidewalk, to address these issues. While he generally does not support the use of eminent domain, Mr. Malaguti feels that public safety plays a significant factor in this particular matter.

Yara Montminy, owner of 2-4 Shaw Court, read a prepared statement from Kevin & Mary Nolan of 6-8 Shaw Court (who could not attend the meeting), in which the Nolans stated their support for the DPW's plans to continue the sidewalk along Nelson Street. Ms. Montminy also provided the Board with a copy of a letter from Merry Alexander of 11 Shaw Court, who also favors the construction of the sidewalk.

Ms. Montminy offered her own perspective on the DPW's proposal, noting that, though the conditions of the intersection at Nelson and Water will never be perfect, the Town's proposal will address the most immediate need. The proposal offered by Mr. Willis to situate the sidewalk on the south side of the street, she said, will place the walkway too close to the home at 29 Nelson Street and force pedestrians to cross the street, in order to access Nelson Park. The Town must do more to address vehicular speeding through the intersection of Nelson and Water streets, Ms. Montminy reiterated, but the sidewalk, in her opinion, is the most immediate public need.

Referencing Ms. Montanari's comments regarding the ZBA decision that required the easement at 29 Nelson Street, Steve Lydon inquired if the ZBA's order still stands. Sid Kashi, Town Engineer, stated his understanding that the easement has not been granted from the owners of 29 Nelson Street.

Amy Lee Durkee of Nelson Court expressed concern about her family's ability to safely walk to Nelson Memorial Park. She urged the Board to pursue the proposed easement, as well as other safety measures, to make the intersection safer, not only for residents but for the visitors who contribute to Plymouth's economy.

Nicole Hales of 1 Shaw Court stated her agreement with previous speakers that the proposed easement is necessary, to provide safer pedestrian access.

George Frobig of 4 Shaw Court stated his belief that the Town must address the way vehicular traffic passes through the intersection of Water and Nelson streets, whether through police enforcement, a three way stop, speed bumps, or the prohibition of through traffic.

Lisa Tynin of 20 Nelson Street reported that she has been asking the Town to continue the sidewalk along Nelson Street since she moved to her home in 1989. Ms. Tynin expressed her opinion that the Town's proposal to construct a sidewalk along the front of 32 Nelson Street will be beneficial to, and safe for, her neighborhood.

Clare Montanari offered to provide the Board with a copy of the request that Mr. Willis' family brought forth to get the sidewalk easement contingency removed from their zoning permit (Zoning Board of Appeals Case # 3663), dating back to December 2012. Ms. Montanari reported that she attended the ZBA hearing, at which Mr. Willis' family's request was denied.

Annette Crow of 14 Nelson Street reported that she and all of her neighbors support the Town's proposal.

Seeing no further requests to offer comment on the proposed taking, Chairman Muratore closed public comment.

In response to questions from Chairman Muratore, Ms. Arrighi indicated that staff can consider and investigate the installation of traffic calming measures and/or additional barriers at the intersection of Water and Nelson streets, to compliment or enhance the proposed sidewalk. With regard to Mr. Willis' allegations of retaliation, Ms. Arrighi stated that there is no retaliation involved in this matter, and she reaffirmed that she and the DPW Director have always been open to speaking to Mr. Willis and his family.

Selectman Mahoney made a motion to proceed with the proposed taking, by eminent domain, of an easement over a portion of property at 32 Nelson Street, based on the recommendation of Town staff. Selectman Provenzano seconded the motion.

Selectman Mahoney offered his belief that the two issues raised regarding 32 Nelson Street—the easement for the construction of a sidewalk and vehicular access from the rear portion of 32 Nelson Street into and through Nelson Memorial Park—are mutually exclusive. If the property owner has a right to access the public recreation area from the back of his property, he said, the owner must demonstrate rights to such access. In the meantime, Selectman Mahoney explained, the Board is tasked with doing what is best for the community, as a whole, and it has long been evident to many of Plymouth's residents that the provision of pedestrian passage through the intersection of Water Street and Nelson Street requires improvement.

The Board voted 5-0-0 in favor of Selectman Mahoney's motion to proceed with the proposed taking, by eminent domain, of an easement over a portion of property at 32 Nelson Street, based on the recommendation of Town staff.

## TOWN MANAGER'S REPORT

**Thanksgiving Parade Events** – Town Manager Melissa Arrighi commended the staff and volunteers of America's Hometown Thanksgiving Parade ("AHTP") for their efforts in producing yet another very successful Thanksgiving parade. In addition to the parade, she noted, AHTP planned a full weekend of other events related to the holiday that were very successful, including the Friday evening VIP reception at Memorial Hall. Ms. Arrighi gave special recognition to Olly deMacedo, who services as the director of AHTP.

**Winter Holiday Tree** – Ms. Arrighi reported that, due to the size of the Holiday tree that was donated to the Town this year, the Department of Public Works will place the tree in Town Square (as opposed to the usual placement in Shirley Square). Parks Superintendent Ted Bubbins will inform the Kiwanis Club of the alternate location of the tree, she noted,

in the event that the organization needs to make any changes to its "Christmas in Historic Plymouth" activities.

**Water Meter Readings** – Ms. Arrighi informed the Board and the public that, during the course of the most recent batch of water meter readings, the Town's Water Division discovered erroneous readings on a number of accounts. The Water Division has worked diligently to identify those accounts for which inaccurate readings were entered, she reported, and residents will be notified of any discrepancies, in writing. Ms. Arrighi indicated that property owners are being instructed to proceed with payment of their current bill; any miscalculation will be amended on the subsequent water bill. The Town is working to resolve this unfortunate error, she said, and procedures will be put in place to ensure that there is no reoccurrence of this error and inconvenience to the taxpayers.

**Energy Initiatives** – Ms. Arright referenced an update within her Town Manager's Report regarding the Town's energy efficiency initiatives.

**Conflict of Interest Training** – Ms. Arright announced that the Town will host a training on the Conflict of Interest Law at Town Hall from 5:30 - 7:00 p.m. on the evening of Thursday, December 5, 2013. The training, she said, will be provided by Elizabeth Lane of Kopelman & Paige (Town Counsel) and Town Moderator Steven Triffletti.

**Meeting to Discuss Procedures Related to the Acceptance of Private Roads** – Ms. Arrighi informed the Board that she and Selectman Provenzano—along with the Town's Assistant DPW Director, Engineer, and Planning Director—attended a meeting at the law offices of Kopelman & Paige (Town Counsel) to discuss the acceptance of private roads.

Selectman Provenzano reported that, during the meeting, Town Counsel explained why the method by which the Town of Plymouth accepts private roads contains some fatal flaws. Selectman Provenzano noted that he will bring the information he received from Town Counsel to the Roads Advisory Committee, prior to returning before the Board for a follow-up report.

**FY2015 Budget** – Ms. Arrighi explained that Selectman Tavares had asked her to commence the budget development process earlier than usual, so that the Selectmen could have an opportunity to review and agree upon a final budget recommendation, prior to review by the Advisory & Finance Committee. Ms. Arrighi asked the Board to prepare for making a decision on its budget recommendation by the meeting of December 17, 2013.

In advance of the formal presentation on the FY2015 Budget (scheduled for December 10, 2013), Ms. Arrighi reviewed a number of the key factors that shaped her recommendations. From contractual cost-of-living-adjustments (COLA's) and rising health insurance costs to escalating maintenance expenses, she said, Plymouth's fixed costs are growing at a rate that makes it impossible to keep the total budget increase at a manageable level. Ms. Arrighi noted that there are projects that the Selectmen have asked staff to pursue—such as appraisals of Chapter 61 lands and title research on the 1,000 Acres site—but, based on the challenge posed by the Town's fixed costs, such projects must be eliminated from the

budget. Residents frequently request additional services—e.g. additional staffing at Morton Park, increased enforcement of the Town's zoning bylaws, improved web technology—but such additional services come at an expense that cannot be accommodated, if the Town is to keep the anticipated tax increase to a minimum. Ms. Arright noted that she will likely have to ask the School Department to make cuts to its budget, as well.

## COMMITTEE LIAISON / DESIGNEE UPDATES

**400<sup>th</sup> Anniversary Committee / Plymouth 400, Inc.** – Vice Chairman Brewster provided the Board with an in-depth status update on the Town's 400<sup>th</sup> Anniversary Committee and the private non-profit corporation, Plymouth 400, Inc. During its most recent meeting of November 21, 2013, she reported, the Town's 400<sup>th</sup> Anniversary Committee voted to dissolve itself, following a lengthy discussion about its role within, and progress towards, the planning of the event. The Town committee was tasked with the oversight of planning for the anniversary and the identification of infrastructure projects related to the event. Vice Chairman Brewster offered her observation that, despite progress on the infrastructure initiatives, the tasks upon which the committee was falling short were outreach and planning.

In consideration of the dissolution of the Town's committee, Vice Chairman Brewster indicated, Plymouth 400, Inc. has agreed to take on the full responsibility of planning and fundraising for the event, with assistance from those members of the Town's committee who would be willing to resume their service as a member of the corporation. The corporation will meet in February to discuss the combination of the two groups and develop an organizational chart. As part of the merging of the two groups, she noted, Plymouth 400, Inc. has agreed to operate under the guidelines of the Open Meeting Law.

Vice Chairman Brewster updated the Board on Plymouth 400, Inc.'s federal 501(c)(3) (non-profit) status, noting that an error in the corporation's filing with the Massachusetts Secretary of State has been quickly and officially corrected. In the meantime, she said, Plymouth 400, Inc. is seeking candidates to take on the role of the organization's full-time executive director. Vice Chairman Brewster informed the Board that several of Plymouth 400, Inc.'s planning initiatives are moving forth, including the touring exhibit (scheduled to begin touring in 2017), a student exchange trip with Plymouth, United Kingdom, and a number of fundraising events.

Vice Chairman Brewster reminded residents to submit their orders for Plymouth's 400<sup>th</sup> Anniversary license plate, as soon as possible. To date, she noted, 1,070 have been collected; once the goal of 1,500 minimum orders is reached, the plates can go into production.

On a motion by Selectman Provenzano, seconded by Vice Chairman Brewster, the Board voted to formally dissolve the Town's 400<sup>th</sup> Anniversary Committee. Voted 5-0-0, approved.

## **OLD BUSINESS / LETTERS / NEW BUSINESS**

**NRC Webinar on Independent Spent Fuel Storage Installation at Pilgrim** – Vice Chairman Brewster reported that the United States Nuclear Regulatory Commission ("NRC") will host a webinar on the Independent Spent Fuel Storage Installation ("ISFSI") at Pilgrim Nuclear Power Station. The webinar, she indicated, will be held at 3:00 p.m. on Thursday, December 12, 2013, and online registration is required. Vice Chairman Brewster encouraged those wishing to participate in the webinar to contact the Selectmen's Office for more information.

**1820** Courthouse / Municipal Complex Proposal – Selectman Mahoney asked that the Plymouth Growth & Development Corporation ("PGDC") be asked to weigh-in on the proposal to relocate Town Hall to the 1820 Courthouse site, with respect to parking. Selectman Mahoney noted that he is not looking for an endorsement of the project from the PGDC, but, rather, he is requesting commentary on how the proposal would fit into the PGDC's overall vision for parking in the downtown.

**Marshfield Coastal Citizens Coalition / Flood Insurance Affordability Act** – Chairman Muratore referenced correspondence from the Marshfield Coastal Citizens Coalition regarding the Homeowner Flood Insurance Affordability Act of 2013. The legislation, he explained, will postpone significant insurance rate increases that a number of coastal homeowners will experience as a result of the new floodplain maps issued by the Federal Emergency Management Agency ("FEMA").

On a motion by Selectman Tavares, seconded by Selectman Mahoney, the Board voted to endorse, and send a letter of support for, the passage of the Homeowner Flood Insurance Affordability Act of 2013. Voted 5-0-0, approved.

**Council on Aging Gala** – Chairman Muratore reminded the Board and the public that the Council on Aging will host its  $40^{th}$  anniversary celebration at the Senior Center on the evening of December 6, 2013.

## ADJOURNMENT OF MEETING
