## CALL TO ORDER

Chairman Tavares called the meeting to order at 6:42 p.m. and led the Pledge of Allegiance.

## 2015 ANNUAL TOWN MEETING ARTICLES

#### Article 12 – Chapter 90 Funds

On a motion by Selectman Provenzano, seconded by Selectman Mahoney, the Board voted to recommend Article 12 to the 2015 Annual Town Meeting. Voted 4-0-0, recommended.

#### Article 20 – Swearing in Elected and Appointed Officials

The Concern has been that there are people who have not been sworn in which creates a liability for the Town. The Proposal presented is that people will be given 30 days after they are appointed to be sworn in. If not sworn in, their appointment would be vacated.

On a motion by Selectman Provenzano, seconded by Selectman Page, the Board voted to recommend Article 20 to the 2015 Annual Town Meeting. Voted 4-0-0, recommended.

# DISCUSSION ON TOWN ELECTION HOURS

The Board of Selectmen can set the local election hours within the state limits. Only those residents who are out of Town qualify for absentee ballot. Recommend elections hours would be from 7 am to 7 pm.

Selectman Provenzano would like this to be widely publicized.

On a motion by Selectman Mahoney, seconded by Selectman Page, the Board voted to set the local election hours for 7am to 7pm for the May 9, 2015 election. Voted 4-0-0, approved.

#### TOWN MANAGER REPORT

Valentine Gala will be held on Saturday February 7, 2015

New Town Hall – The Town is under contract with Page Construction for the demolition of the old police station, the Commissioner's Building and portions of the 1820 structure. Interior demo work has begun and removal of the buildings will be complete by approximately the end of March or mid-April.

First Parish Church – Secretary William Galvin and State Historic Preservation Officer Brona Simon, from the Massachusetts Historical Commission, have officially informed the Town that the First Parish Church was accepted on December 2, 2014, by the National Park Service, Department of the Interior, for listing in the National Register of Historic Places.

Chapter 90 Funds – Governor Baker has notified the Town that the Chapter 90 local transportation aid funding for FY15 has increased from \$200 million to \$300 million statewide. The Town of Plymouth's Chapter 90 apportionment has increased from \$1,513,944 million to \$2,270,917. This is great news for Plymouth as we have about 5 million in backlog projects that we need to do with Chapter 90 funds, and this will just provide additional assistance in accomplishing more of these projects.

MMA Conference – The Massachusetts Municipal Association 2015 Annual Meeting and Trade Show is the weekend of January 23, 2015. The focus for this year is "Our Cities and Towns, American Democracy at Work". The educational workshops will explore topics such as economic development, municipal law, JLMC, energy, environmental issues, Veteran's services, cultural districts, and CPA.

Liens on 3<sup>rd</sup> Party claims IOD – HR Director Cindy DePina has informed me that she uncovered that the Town of Plymouth had not been placing liens on third party claims for injured on duty cases. What this means is that an employee out on inured on duty could be suing a third party, however, upon settlement the Town was not being reimbursed by that same third party. She has now instituted a procedure where her staff will identify these cases and immediately begin the process of recovery of funds.

# JOIN T MEETING WITH COUNTY COMMISSIONER – POLICE Parking Lot

All Commissioners present and Counsel Don Nagle.

Ms. Arrighi – Town is moving forward with cleanup of the Police Parking Lot. DEP issued a condition to meet with the County to come up with a long term monitoring plan. County did file demand letter to protect interest.

Selectman Tavares stated that there were a couple of meetings to address the mandate from DEP.

Don Nagle – Agree with the characterization on two distinct issues

- 1. Obligation to share monitoring
- 2. Issue demand letter under Chapter 21a

The Town and County have been unable to come up with an agreement.

The County believes the Town is responsible for trash and monitoring.

The County has appealed the corrective action by DEP.

The County is interested in conducting activities on the former site and is seeking cooperation from Town for these future activities.

The County feels they have made significant efforts to come to an agreement.

On a motion by Selectman Provenzano, seconded by Selectman Page, that the Town contribute 50% on the cost of monitoring of the site subject to Town Meeting Approval, withdraw of demand letter and withdraw of DEP appeal. Voted 4-0-0, approved.
