ADMINISTRATIVE NOTES

Meeting Minutes / October 12, 2010 – On a motion by Selectman Quintal, seconded by Selectman Muratore, the Board approved the minutes of the October 12, 2010 Selectmen's

meeting. Voted 3-0-1, approved, with an abstention from Vice Chairman Mahoney, as he did not attend the October 12, 2010 meeting.

Restoration Easement – The Board accepted a *Restoration Easement* from Jeffrey C. Fischer and Cynthia B. Fischer of 158 Sandwich Street to the Town, by and through its duly authorized Conservation Commission, for conservation/restoration purposes on a portion of property at 158 Sandwich Street.

Conflict of Interest Disclosure – The Board acknowledged the *Disclosure of Financial Interest by Municipal Employee* submitted by Lynn Holdsworth, member of the Cultural Council, and determined that the interest is not so substantial as to be deemed likely to affect the integrity of services which the Town may expect from the employee/appointed official.

DOT Grant Assurances for Airport – The Board approved and authorized the Chairman to sign the Massachusetts Department of Transportation (“MassDOT”) Grant Assurances for the Delta Taxiway Project at Plymouth Municipal Airport.

Retirement Benefits, Eligibility and Contribution Document – Town Manager Mark Stankiewicz presented the Board with an amended copy of the *Retirement Benefits, Eligibility Standards and Contribution Percentages for Health and Dental Insurance* document, for review and approval. The amendments made to the document, Mr. Stankiewicz explained, represent recent changes made by the Social Security Administration (“SSA”) to Medicare Part B premiums and employee reimbursements. The Town pays employee reimbursements in advance, he said, and, therefore, in order to provide the newly adjusted payments to retirees by the standard December 1, 2011 payment schedule, the document must first be modified and approved by the Board.

Selectman Quintal noted that members of the Town’s Insurance Advisory Committee (“IAC”) were present in the audience, and, thus, Chairman Hallisey allowed the chairman of the IAC to address the Board regarding the benefits document.

Dale Webber, chairman of the IAC, questioned whether process was adequately followed with the benefits document. The IAC, he explained, is a statutory committee that makes advisory recommendations to the Town on employee insurance-related matters, but the Town Manager, he said, did not provide the committee with an opportunity to review the changes made to the document. Mr. Webber commented that the committee is very sensitive as to how changes in benefits are implemented and inserted into the document, and, thus, he asked the Board to postpone its decision on the matter until the IAC can review the changes at its December 3rd meeting.

Mr. Stankiewicz stated that the new rates were forwarded to Mr. Webber on the same day they were issued from the SSA (November 10, 2010). Retirees expect their checks on December 1st to pay their January-February-March Medicare Part B premiums by January 1st, he explained. If the Town is to issue these payments on time by December 1st, the changes must be ratified as soon as possible.

Discussion ensued between the Board, Mr. Stankiewicz, and Mr. Webber regarding the changes made by SSA and the process by which the Town issues advance reimbursements. During the dialogue, the Town's Human Resources Director, Roberta Kety, provided information relative to the reimbursement schedule. Many of the Town's 800 retirees who receive Medicare Part B reimbursements will likely become anxious if payments are not distributed according to the usual schedule, Ms. Kety said.

Mary Guidetti of the Plymouth Retired Employee Association ("PREA") suggested that the Town cut and hold the checks (with the new rates) in advance of a recommendation from the IAC and a final decision from the Selectmen. Ms. Guidetti also asked that explanations be provided to retirees who receive the increased payments, to dispel any confusion.

Selectman Muratore questioned why the IAC or even the Board of Selectmen would need to approve the rates issued by SSA, if the amounts are indisputable. Mr. Webber stated that the IAC would like to see the amendments made to the benefits document. Mr. Stankiewicz explained that the only amendments made to the document were the new, increased rates.

Mr. Stankiewicz reiterated that the Town received notice of the new rates from SSA on November 10, 2010, leaving little time for the Board to formally ratify the amended amounts before reimbursement checks must be issued. Mr. Webber acknowledged that the rates cannot be disputed by the IAC but contended that his committee should be given the opportunity to see the amended document and offer a recommendation to the Selectmen.

Members of the Board offered final comments on Mr. Webber's request to delay its decision on the benefits document. Chairman Hallisey put emphasis on the importance of process. Vice Chairman Mahoney inquired if the IAC could move its next meeting up from December 3rd, to accommodate the December 1st reimbursement schedule.

Selectman Muratore made a motion to approve the *Retirement Benefits, Eligibility Standards and Contribution Percentages for Health and Dental Insurance* document, as amended, contingent upon the recommendation provided by the IAC. Vice Chairman Mahoney seconded the motion.

Mr. Stankiewicz asked if Mr. Webber could commit to a date on which the IAC could meet and offer a recommendation. Ms. Kety offered her assessment that waiting until the IAC meets on December 3rd will push the issuance of payments at least a week beyond that date. Mr. Webber affirmed that he would call a meeting of the IAC for the early part of the week following the Board's (current) meeting.

Seeing no further discussion, the Board voted 4-0-0 in favor of Selectman Muratore's motion.

PUBLIC COMMENT

Chairman Hallisey opened the meeting to public comment. No citizens came forth.

DISCUSSION ON MEETING PROCEDURES

Selectman Muratore introduced a discussion on procedures for public comment during meetings of the Board of Selectmen. The proposal included in the Board's packet, he noted, was drafted during the time that both he and Selectman Harnais served upon the Town's Advisory & Finance Committee ("FinCom"). Selectman Muratore explained that the purpose behind the policy is to help citizens better prepare themselves for addressing the Board during public meetings, e.g. deadlines and formats for the submission of materials, time frames for presentations, etc.

Selectman Quintal stated that he would not support establishing any policy that would set limits on public comment—this is a task, he said, that should be left to the Chairman and Vice Chairman's discretion.

Selectman Muratore sought to explain that the proposal before the Board is a set of general guidelines—not rules—that would provide clarity for the public as to how public comment and presentations are facilitated, so that they know what to expect when they come before the Selectmen. This measure, he surmised, would also help meetings run more efficiently.

Chairman Hallisey opened the discussion to public comment.

Paul Hapgood speculated whether guidelines would add to the already-intimidating experience of speaking during a public meeting. He advised the Board against setting time limits on public comment.

Ric Cone sang the praises of an open form of government where ordinary citizens can voice their opinions before their local government. Mr. Cone noted that he would not mind a loose protocol for meeting proceedings, so long as public comment is preserved as "sacred."

Ken Buechs spoke against setting any guidelines on public comment.

Kevin Doyle stated that he has no objection to the establishment of basic guidelines around public comment but inquired how comments made during public meetings are met with a response, if the Selectmen cannot engage in a discussion on the issue brought forth.

Assistant Town Manager Melissa Arrighi explained that staff from the Town Manager's Office typically follow-up with citizens who bring issues or concerns forth during public comment.

At the close of public comment, Selectman Muratore wished to make clear that the proposal is in no way intended to limit the speech of citizens who address the Board during public comment. The guidelines, he reiterated, are intended to provide the public with a better understanding of what to expect when appearing before the Board.

Chairman Hallisey offered his position that there is no need to change the Board's current means of conducting meetings. Following some brief final comments, discussion then closed.

DISCUSSION ON BOARD DESIGNEES AND ALTERNATES

Chairman Hallisey explained that, when he could not attend a recent meeting of the Plymouth County Advisory Board (as Plymouth's delegate), it would have been helpful to send an alternate designee in his stead.

Mr. Stankiewicz noted that the ability of the Board to send an alternate to serve and vote upon a committee depends upon the structure of the committee itself. There is a difference, he said, between committee liaisons and actual sitting, appointed members.

The Board's assistant, Tiffany Park, reported that, in the case of the County Advisory Board, the County does allow each Town to name an alternate member of the Board of Selectmen who can serve in instances where the primary delegate cannot attend a particular meeting. The Board, she said, would have to vote to name that specific alternate member.

Mr. Stankiewicz stated that staff can review the list of those committees upon which a member of the Board serves to ascertain whether an alternate is permitted. Any member of the Board is free to attend the Town's committee meetings, he said, with the understanding that they cannot deliberate or vote upon matters unless they are a duly-appointed member.

Chairman Hallisey accepted Mr. Stankiewicz suggestion that staff research those committees that allow alternate delegates from the Board of Selectmen.

BOARD LIAISON / DESIGNEE UPDATES

Nuclear Matters Committee – Selectman Muratore reported that the Nuclear Matters Committee (“NMC”) met on the evening of November 16th, at which there was discussion about the difficulty that some may have in hearing the emergency siren system. The NMC, he said, will hold a follow-up meeting with Plymouth's Director of Emergency Management, Aaron Wallace, to discuss other ways to effectively communicate emergency information to the public.

Community Preservation Committee – Selectman Quintal asked if staff could set up a date on which the Community Preservation Committee could use the Mayflower Room to hold a televised meeting on the application process for Community Preservation funds.

OLD BUSINESS / LETTERS / NEW BUSINESS

Moose Lodge Thanksgiving Dinner – Selectman Muratore noted that the Plymouth Moose Lodge plans to host a Thanksgiving Dinner at its headquarters on State Road, with the goal of providing holiday meals to 200 families. The Lodge, he said, is seeking donations and volunteers for the event.

FEMA Emergency Management Drill – Chairman Hallisey reported that he participated in a recent drill conducted by the Federal Emergency Management Agency (“FEMA”) at the Town’s Emergency Operations Center. The exercise, he explained, went well under the leadership of Emergency Management Director Aaron Wallace.

Leaves on Lincoln Street – Selectman Quintal noted the amount of fallen leaves accumulating outside of Town Hall on Lincoln Street, and, thus, he asked if the DPW could clear them as soon as possible.

TOWN MANAGER’S REPORT

Veterans Day Parade and Sherman Memorial Dedication – Mr. Stankiewicz reported that the Town was well represented during its recent Veterans Day Parade, and he thanked Plymouth’s Veterans Agent, Roxanne Whitbeck, for her work in organizing the event. The dedication of the memorial to Sgt. Benjamin Sherman, he noted, was held in Manomet following the parade.

Town Brook Featured in Publication – Mr. Stankiewicz was pleased to report that the Town Brook Dam Removal Project was recently featured in a publication by the name of *The Current*, published by American Rivers. Plymouth’s DPW Environmental Manager, David Gould, was interviewed as part of the coverage of Plymouth’s efforts to return parts of Town Brook to its natural state, he informed the Board.

Thanksgiving Day Parade – Mr. Stankiewicz reminded the Board and the public of the events taking place as part of the America’s Hometown Thanksgiving Day Parade festivities scheduled for Friday, Saturday, and Sunday – November 19, 20, and 21.

Dog Report for Plymouth Long Beach – Mr. Stankiewicz referenced the report provided to the Board relative to records of unleashed dogs on Plymouth Long beach during the 2010 season. The report, he said, unfortunately does not demonstrate the Town’s concerted efforts to comply with the State-imposed dog ban.

At the close of Mr. Stankiewicz’s report, Chairman Hallisey wished everyone a Happy Thanksgiving and noted that the Board would not meet on November 21, 2010.

ADJOURNMENT OF MEETING

On a motion by Selectman Muratore, seconded by Vice Chairman Mahoney, the Board voted to adjourn its meeting at approximately 8:05 p.m. Voted 4-0-0, approved.
