## **CALL TO ORDER**

Chairman Hallisey called the meeting to order at 7:00 p.m. and led the Pledge of Allegiance.

## **TOWN MANAGER'S REPORT**

**Council on Aging Volunteer Recognition Luncheon** – Town Manager Mark Stankiewicz informed the Board that he attended the Council on Aging's annual Volunteer Recognition Luncheon held on December 1, 2011. The event, he said, is held to honor the numerous volunteers who donate their time to deliver meals, drive seniors to their medical appointments, and assist with programs and services provided at the Council on Aging—saving the Town nearly \$250,000 in programmatic expenses.

**Council of SEMASS Communities** – Mr. Stankiewicz reported that, on Thursday, December 1, 2011, he and DPW Director Jonathan Beder attended a luncheon sponsored by the Council of SEMASS Communities, at which a number of municipal solid waste-related matters were discussed. Of particular note, he said, was the announcement that SEMASS/Covanta has established a facility in Pennsylvania for Sustainable Materials Recovery (computer and electronic recycling), from which services will be soon be expanded to the New England area.

**South Eastern Economic Development Corporation (“SEED”) Business Award** – Mr. Stankiewicz was pleased to report that the South Eastern Economic Development Corporation (“SEED”) recently named the Plymouth Industrial Development Corporation (“PIDC”) as the recipient of its Business Advocate of the Year award. The award, he explained, was presented to the PIDC for its role in developing the Plymouth Industrial

Park (leading to the creation of thousands of local jobs) and its philanthropic contributions to a number of community endeavors.

**Plymouth Public Library 20<sup>th</sup> Anniversary** – Mr. Stankiewicz announced that the Plymouth Public Library Corporation’s Board of Trustees will be holding a celebration in honor of the Library’s 20 years of service at the location on South Street. The event, he said, will be held on Friday, December 9, 2011.

**Electronic Waste Collection Day** – Mr. Stankiewicz noted that the South Shore Recycling Cooperative will hold a free electronic waste collection day from 9:00 a.m. to 3:00 p.m. at the Park & Ride lot on Commerce Way (across from Colony Place) on Saturday, December 10, 2011. Residents may bring items such as televisions, computers and computer accessories, stereo equipment, radios, cell phones, toasters, irons, and any small item with an electrical cord for recycling, he said.

School Committee Chairman Dennis Begley called a meeting of the School Committee to order at 7:15 p.m. Planning Board chairman Marc Garrett noted that he could not call a meeting of his board to order, in absence of a quorum.

Selectman Muratore introduced the discussion, noting that Town staff and representatives of the Board of Selectmen, Planning Board, and School Committee have been collaborating with Jordan Hospital on the Healthy Communities Initiative.

Peter Holden, Chief Executive Officer for Jordan Hospital, provided a brief presentation on health care statistics and the nation's expenditures on health care, as compared to other industrialized nations. Mr. Holden explained that healthcare reform is already coming to Massachusetts, and, thus, citizens will see very different system of care in the future. With the assistance of municipalities and schools, communities can make a difference in the effort to provide its citizens with the ability to live healthier, more active lifestyles.

Mark Fenton, an expert on healthy communities who is working with Jordan Hospital on the initiative, provided an extensive presentation on the ways in which municipalities can take a proactive role in setting the backdrop for healthier living. Within his presentation, Mr. Fenton described the concept of "free range" activity, illustrating how children's playtime and activities have changed over the decades with the advent of television, computers, and video games.

Mr. Fenton provided a number of statistics on health and physical activity, noting the data that currently demonstrates that Americans are not getting the proper amount of regular physical exercise. Research tells us, he said, that the improvement of municipal sidewalks, biking lanes, trails, parks, and village centers can have a direct and meaningful impact on a community's physical activity, by encouraging people to exercise without even knowing that they are doing so. Thoughtful engineering can dramatically improve safety, Mr. Fenton explained, and statistics show that the increase of pedestrian and bike trips reduces motor vehicle accident and fatality rates.

Mr. Fenton then discussed how improved access to proper nutrition through better food markets, agricultural programs and farmers' markets, and healthier meals in school systems affects a community's overall health. Mr. Fenton closed his presentation with a list of compelling reasons as to why communities should embrace such measures, noting that healthier communities typically attract visitors and have better real estate values.

Members of the Planning Board and School Committee discussed the ways in which their respective boards will participate in the Healthy Communities Initiative. Mr. Garrett described how the Planning Board can work towards shaping the character of Plymouth's open space, transportation flow, and village planning to provide enhanced pedestrian access. Mr. Begley talked about the new high school and the new state laws requiring improved nutrition in public schools. DPW Director Jonathan Beder spoke about the specific ways in which his department can provide Plymouth with better sidewalks, roads, and parks.

Chairman Hallisey opened the discussion to public comment.

Rich Rothstein asked the Selectmen to consider paving Drew Road (with the inclusion of a bike lane), to improve the connection between West Plymouth to Long Pond Road, because there are few east-west corridors in Plymouth.

No further citizens came forth to speak. Chairman Hallisey offered a few remaining remarks before thanking the members of the Planning Board and School Committee for their participation in the presentation.

Mr. Begley adjourned the meeting of the School Committee at approximately 8:35 p.m.

## **COMPREHENSIVE WASTEWATER MANAGEMENT PLAN**

Following a brief recess, Chairman Hallisey reconvened the meeting at 8:45 p.m.

Wastewater Superintendent Gary Frizzell provided a presentation on the development of the Town's Comprehensive Wastewater Management Plan ("CWMP").

Mr. Frizzell stated that the Department of Public Works fully understands the Board's desire that the Town's wastewater treatment facility be used to its full capacity. To that end, he said, the department is working with a consulting service, AECOM, to establish a Scope of Services for the CWMP.

Mr. Frizzell discussed the objectives of the CWMP and displayed maps showing where the Town's sewer lines extend throughout Town. There are just over 3,000 sewer service accounts covering about 18,000 of the 56,000 people living in Plymouth, he noted. The two areas to which the DPW plans to expand sewer service are Warren Avenue to Plimoth Plantation and Samoset Street, west of Route 3. Mr. Frizzell stated his professional belief that the wastewater facility is capable of handling these added zones.

Mr. Frizzell and DPW Director Jonathan Beder responded to a handful of questions from the Selectmen regarding the current status of the Town's sewer infrastructure. In response to an inquiry from Vice Chairman Mahoney, Mr. Beder explained that it will be a significant number of years before the Town can provide sewer infrastructure to the West Plymouth, Manomet, and Cedarville areas of town.

Representatives from AECOM introduced themselves to the Board and talked about their experience in developing such plans for sewer management and expansion. Mary Monahan of AECOM talked about the funding opportunities that may be available through the state for municipal expansion proposals.

Mr. Beder noted that he and his colleagues will return before the Board in the Spring to present the fully developed management and expansion plan.

Chairman Hallisey opened the presentation to public comment. No citizens came forth to speak.

## **DISCUSSION: CREATION OF NATURAL RESOURCES COMMITTEE**

Selectman Harnais introduced a discussion on the creation of a Natural Resources & Coastal Beaches Committee, which would effectively revise and replace the Town's Tidal Beaches Advisory Committee ("TBAC"). The idea, he explained, stemmed from a recommendation made (months earlier) by the Consolidation Committee to consolidate the Harbor Committee and TBAC into one entity. Selectman Harnais noted that, because the TBAC had not yet been given an opportunity to hear this recent proposal for the Natural Resources Committee, the Selectmen will not be asked to vote on the matter until a later date.

The Board debated whether it should also hold its discussion on the matter until the TBAC has had an opportunity to review and comment upon the proposal. The discussion then migrated to the specifics outlined within the proposal regarding the number of seats on the committee, the composition of its membership, and the beaches/neighborhoods that would be represented by each designated seat.

As discussion came to a close, Chairman Hallisey invited Stephanie Fugazzi, chairman of the TBAC, to offer comments on the proposal.

Ms. Fugazzi reported that the TBAC currently has a full complement of members—including a naturalist and a biologist—who are enthusiastic about continuing their work with the committee. The group, she said, heeded the Selectmen's previous request to include all of the Town's coastal areas within its scope of work, and members have since reached out to Plymouth's various beach communities and associations. Ms. Fugazzi emphasized the importance of having a liaison from the Board of Selectmen to work and communicate with the committee on a regular basis.

Chairman Hallisey opened the discussion to public comment.

Kevin Doyle of Precinct 6 (Manomet) noted that his previous concerns regarding the TBAC's limited focus on Long Beach have been alleviated by the committee's recent efforts to reach out to the White Horse Beach neighborhood. Mr. Doyle recommended that the Board add more seats to the TBAC that would represent specific beaches (like White Horse Beach and/or Nelson Beach), to ensure a broader focus on the Town's coastal areas. Some neighborhood associations are trying to stop access to their respective beaches, he said, but Plymouth's coastal areas should, in his opinion, be open to everyone.

Following the close of public comment, the Selectmen opted (by apparent consensus) to allow the TBAC an opportunity to review and comment on the proposal to create a Natural Resources & Coastal Beaches Committee.

## **BOARD LIAISON / DESIGNEE UPDATES**

The Selectmen offered no reports/updates on Town committee activity.

## **OLD BUSINESS / LETTERS / NEW BUSINESS**

**Repair of Utility Poles / Disruption to Roadway Surface** – Chairman Hallisey commented on the number of “sistered” utility poles that have remained unrepaired throughout various areas in town. He questioned whether the Selectmen could enact a policy by which the Town can require its service providers to remove structurally-compromised poles within a certain time frame—as opposed to the current practice of stabilizing the pole on another pole, indefinitely.

Chairman Hallisey consented to a request from an audience member to speak on the matter.

Everett Malaguti III, Town Meeting Member for Precinct 1, commented that there are a number these “sistered” poles within his precinct. He cited a pole stabilized by rope on Westerly Road, about which he has received no response after repeated calls to NSTAR. In those cases where the poles are finally repaired, he explained, NSTAR rarely returns the sidewalks to their original condition, using asphalt rather than concrete.

Chairman Hallisey reiterated his wish that the Selectmen initiate a policy on the prompt repair of compromised utility poles. Selectman Harnais noted that the Town’s DPW Director is in the process of updating the Town’s policy on the opening of public roads and sidewalks for utility work. As part of the update to the policy, Selectman Harnais reported, the DPW Director will require utility companies to repave the roadway, edge-to-edge, following any disruption caused as a result of repair work.

## **ADJOURNMENT OF MEETING**

On a motion by Selectman Harnais, seconded by Selectman Muratore, the Board voted to adjourn its meeting at approximately 9:50 p.m. Voted 5-0-0, approved.
