Laurie Miner, Sketch Plan Application - Map 17, Lot 45

- Scott Miner, husband of Laurie Miner, is before the board with a sketch plan application for a home auto repair business at their home at 108 Tiger Hill Road.
 - Member Charles Finger verifies that the zoning is Rural Residential one (RR1), and Code Enforcement Officer Nick Adams confirms that it is. According to the Comprehensive Land Use code an auto repair business is not allowed in this zone.
 - Mr. Miner points out the fact that there is an auto repair business less than a mile from his home, however it is located in Oxford. He finds it frustrating that it is not allowed in Poland.
 - Member Charles Finger reminds him that it is ok to fix your own car at your home, or even a family member's, but he would be unable to do it as a business.

- Mr. Miner informs the board that this situation started with a complaint to the Code Enforcement Office that they were operating a junk yard; however he makes it clear that three of the cars on the lot are registered to them.
- There is no public comment.
- Code Enforcement Office Nick Adams reminds the board that the definition for home occupation states that: vehicle body shops, vehicle repair and vehicle sales shall not be considered a home occupation.

Joseph McMorrow, Sketch Plan Application - Map 12, Lot 16A

- Ted Morris is before the board representing Joseph McMorrow, owner of 12-16A. They are requesting a change of use for the single family two (2) bedroom home on the lot, in order to open a three (3) chair hair salon.
 - This would be considered a business primary function use, and it is allowed in the general purpose zone (GP).
 - Traffic, parking, and waste water will be addressed in the site plan application.
 - There is currently a second building on the lot that is used for auctions. Salon parking will be roped off during these auctions.
 - o The building will no longer be a dwelling unit.
- The applicant will be requesting a waiver for the survey and engineering requirements on the site plan application.
 - The board is ok with this. There will be no exterior site changes other than minor signage.
 - Signs will need to meet the ordinance, and will be permitted through the code enforcement office.
- Members of the public are in favor of the project.
