Barry Chandler, Formal Shoreland Zoning Application – Map 46, Lot 9

- Stuart Davis and John Petrocelli are before the Board representing the applicant Barry Chandler. The lot is currently vacant.
- A year or so ago the home owners association took it upon themselves to install two eighteen inch (18") culverts under the road, one of which deposits onto Mr. Chandlers property. They also installed a ditch from the culvert to the shore. Mr. Chandler was never notified that this was being done. No permits were obtained and it has created a significant erosion problem. The proposed plan adds a plunge pool at the end of the culverts, check dams in the ditch, and a level lip spreader fanning water before it reaches the lake. The ditch would also be straightened. Sue Gammon from Androscoggin Valley Soil and Water has approved of the proposed plan.
 - Code Enforcement Officer Nick Adams does not believe there is a formal road association.
 - Maureen Mildram is a seasonal resident of the neighborhood and she does pay yearly dues for road maintenance.
 - Member Charles Finger asks her if she knows who is responsible for the culverts, and she does not.
 - Member George Greenwood asks all of the abutters in the room
 if they pay road maintenance dues, and they do however it is
 unclear who they pay, and what that persons role is.
 - o Maureen Mildram asks the Board what is wrong with the current culverts.
 - Vice Chairman James Porter reminds her that they were installed without the required permits, and without the property owner's permission.
- The applicant has applied for a Permit by Rule from the Department of Environmental Protection.
- The septic system shown on the plan has been redesigned. It will be in the same spot. Stuart Davis will submit an updated plan.
- Vice Chairman James Porter makes a motion to accept the checklist for Barry Chandler, Formal Shoreland Zoning Application – Map 46, Lot 9 as complete, seconded by Member George Greenwood. No discussion.
